1 A BILL for an Act to create and enact subsection 8 to section 12-47-21 and a new subsection to

- 2 section 12-47-36 of the North Dakota Century Code, relating to wireless electronic
- 3 communications devices on or within premises under the control of the department of
- 4 corrections and rehabilitation and records of offenders; to amend and reenact subsection 7 of
- 5 section 12-47-21 of the North Dakota Century Code, relating to the definition of contraband; to
- 6 repeal section 12-47-38 of the North Dakota Century Code, relating to contracting with county
- 7 jails to house female prisoners; to provide a penalty; and to declare an emergency.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9 **SECTION 1.** Subsection 8 to section 12-47-21 of the North Dakota Century Code is

10	created and	d enacted as follows:	

11	<u>8. a.</u>	It is unlawful for a penitentiary inmate to willfully manufacture, possess, or use
12		a wireless electronic communications device on or within any premises under
13		the control of the department of corrections and rehabilitation or any of its
14		divisions except for law enforcement purposes.
15	<u>b.</u>	It is unlawful for any person to willfully deliver, or possess with intent to

- 16 deliver, a wireless electronic communications device to a penitentiary inmate
- 17 or to any person for redelivery to a penitentiary inmate, or to allow a
- 18 penitentiary inmate to possess or use a wireless electronic communications
- 19 device, on or within any premises under the control of the department of
- 20 <u>corrections and rehabilitation or any of its divisions except for law</u>
- 21 <u>enforcement purposes.</u>

22 <u>c.</u> <u>A violation of this subsection is a class C felony.</u>

23 SECTION 2. AMENDMENT. Subsection 7 of section 12-47-21 of the North Dakota
24 Century Code is amended and reenacted as follows:

1	7.	As used in this section, "controlled substance" is as defined in subsection 6 of			
2		section 19-03.1-01 and includes counterfeit substances as defined in subsection 7			
3		of section 19-03.1-01. As used in this section, "willfully" is as defined in section			
4		12.1-02-02. As used in this section, "alcohol" and "alcoholic beverage" are as			
5		defined in section 5-01-01. As used in this section, "tobacco" means any form of			
6		tobacco, including cigarettes, cigars, snuff, or tobacco in any form in which it may			
7		be used for smoking or chewing. <u>As used in this section, a wireless electronic</u>			
8		communications device includes a cellular telephone, personal digital assistant,			
9		pager, mobile broadband card, internet router, digital camera, two-way radio,			
10		modem, or any other electronic device capable of wireless transmission, reception,			
11		interception, or storage of oral communications, text, electronic mail, video or			
12		photograph images, data signals, or radio communications, and also includes a			
13		component of a wireless electronic device, regardless whether the component			
14		itself is able to transmit, store, or receive oral communications, text, electronic			
15		mail, video or photograph images, data signals, or radio communications. A			
16		wireless electronic communications device does not include a medically prescribed			
17		device or any other device approved by the department.			
18	8 SECTION 3. A new subsection to section 12-47-36 of the North Dakota Century Code				
19	19 is created and enacted as follows:				
20		The medical, psychological, and treatment records of the department relating to			
21		persons in the custody or under the supervision and management of the division of			
22		adult services of the department of corrections and rehabilitation may be disclosed			
23		for the purpose of conducting research and educational activities. A person			
24		conducting research or educational activities may not redisclose identifying			
25		information received under this subsection.			
26	SEC	CTION 4. REPEAL. Section 12-47-38 of the North Dakota Century Code is			
27	repealed.				
28	SEC	CTION 5. EMERGENCY. This Act is declared to be an emergency measure.
