- A BILL for an Act to amend and reenact subsection 15 of section 27-20-02, sections 27-20-32.2
- 2 and 27-20-38, and subsection 5 of section 50-11-00.1 of the North Dakota Century Code,
- 3 relating to placement of siblings in foster care and a guardian's duty to exercise due diligence.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Subsection 15 of section 27-20-02 of the North Dakota 6 Century Code is amended and reenacted as follows: 7 15. "Permanency hearing" means a hearing, conducted with respect to a child who is 8 in foster care, to determine the permanency plan for the child which includes: 9 Whether and, if applicable, when the child will be returned to the parent; a. 10 Whether and, if applicable, when the child will be placed for adoption and the b. 11 state will file a petition for termination of parental rights; 12 Whether and, if applicable, when a fit and willing relative or other appropriate C. 13 individual will be appointed as a legal guardian; 14 d. Whether and, if applicable, to place siblings in the same foster care, relative, 15 guardianship, or adoptive placement, unless it is determined that the joint 16 placement would be contrary to the safety or well-being of any of the siblings; 17 Whether and, if applicable, in the case of siblings removed from their home e. 18 who are not jointly placed, to provide for frequent visitation or other ongoing 19 interaction between the siblings, unless it is determined to be contrary to the 20 safety or well-being of any of the siblings;

In cases in which a compelling reason has been shown that it would not be in

the child's best interests to return home, to have parental rights terminated, to

be placed for adoption, to be placed with a fit and willing relative, or to be

2			placed in another planned permanent living arrangement;

In the case of siblings removed from their home who are not jointly placed, to 2 provide for frequent visitation or other ongoing interaction between the 3 siblings, unless it is contrary to the safety or well-being of any of the siblings. 4 3. If the court or the child's custodian determined that continuation of reasonable 5 efforts, as described in subsection 2, is inconsistent with the permanency plan for 6 the child, reasonable efforts must be made to place the child in a timely manner in 7 accordance with the permanency plan and to complete whatever steps are 8 necessary to finalize the permanent placement of the child. 9 Reasonable efforts of the type described in subsection 2 are not required if: 10 A court of competent jurisdiction has determined that a parent has subjected a 11 child to aggravated circumstances; or 12 b. The parental rights of the parent, with respect to another child of the parent, 13 have been involuntarily terminated. 14 5. Efforts to place a child for adoption, with a fit and willing relative or other 15 appropriate individual as a legal guardian, or in another planned permanent living 16 arrangement, may be made concurrently with reasonable efforts of the type 17 described in subsection 2. 18 Removal of a child from the child's home for placement in foster care must be 6. 19 based on judicial findings stated in the court's order, and determined on a 20 case-by-case basis in a manner that complies with the requirements of titles IV-B and IV-E of the Social Security Act [42 U.S.C. 620 et seq. and 42 U.S.C. 6701 21 22 et seq.], as amended, and federal regulations adopted thereunder, provided that 23 this subsection may not provide a basis for overturning an otherwise valid court 24 order. 25 SECTION 3. AMENDMENT. Section 27-20-38 of the North Dakota Century Code is 26 amended and reenacted as follows: 27 27-20-38. Rights and duties of legal custodian. A custodian to whom legal custody 28 has been given by the court under this chapter has the: 29 The right to the physical custody of the child and the right to determine the nature 30 of the care, placement, and treatment of the child, including ordinary medical care

as well as medical or surgical treatment for a serious physical condition or illness

1 which in the opinion of a licensed physician requires prompt treatment, except for 2 any limits the court may impose. The custodian also has the 3 The right and duty to provide for the care, protection, training, and education and 4 the physical, mental, and moral welfare of the child, subject to the conditions and 5 limitations of the order and to the remaining rights and duties of the child's parents or guardian. 6 7 A duty within thirty days after the removal of a child from the custody of the parent 3. 8 or parents of the child, to exercise due diligence to identify and provide notice to all 9 parents, grandparents, and any other adult relative suggested by the parents and 10 grandparents, subject to exceptions due to family or domestic violence, that: 11 Specifies that the child has been or is being removed from the custody of the 12 parent or parents of the child; 13 Explains the options the relative has under federal, state, and local law to b. 14 participate in the care and placement of the child, including any options that 15 may be lost by failing to respond to the notice; 16 Describes the requirements and standards to become a foster family home C. 17 and the additional services and supports that are available for children placed 18 in that home; and 19 Describes how the relative of the child may enter into an agreement with the d. 20 department to receive a subsidized quardianship payment. 21 SECTION 4. AMENDMENT. Subsection 5 of section 50-11-00.1 of the North Dakota 22 Century Code is amended and reenacted as follows: 23 "Family foster home for children" means an occupied private residence in which 24 foster care for children is regularly provided by the owner or lessee thereof to no 25 more than four children, unless all the children in foster care are related to each 26 other by blood or marriage or unless the department approves otherwise for the 27 placement of siblings, in which case such the limitation in this subsection does not 28 apply.
