- 1 A BILL for an Act to create and enact a new chapter to title 17 of the North Dakota Century
- 2 Code, relating to an energy policy commission; to provide for an energy policy commission
- 3 study; to provide for a water resources study; and to provide for a legislative council study.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1.** A new chapter to title 17 of the North Dakota Century Code is created and 6 enacted as follows:

7 Energy policy commission.

A member from the refining or gas-processing industry appointed by the 3 governor; and 4 Additional nonvoting members appointed by the governor. n. 5 Each member of the commission shall serve for a term of two years, beginning July 2. first, may be reappointed for additional terms, and serves at the pleasure of the 6 7 governor. 8 The commissioner of commerce is chairman of the commission. 3. 9 4. The commission shall meet at least four times per biennium or as often as the 10 chairman deems necessary. The commission shall hold at least two public 11 hearings per biennium, at which time interested parties may present testimony 12 regarding issues pertinent to the development of the policy. The department of 13 commerce shall provide staffing for the commission. 14 The commission shall develop a comprehensive energy policy for the state. The 5. 15 commission shall monitor progress made toward the goals outlined in the energy 16 policy and make changes to the energy policy as needed. The commission shall 17 report biennially to the legislative council. 18 The members of the commission who are not state employees are entitled to 6. 19 mileage and expenses as provided by law for state officers and employees. 20 Unless otherwise provided in this subsection, the expenses of appointed members 21 are to be paid by the department of commerce. A state employee who is a 22 member of the commission must receive that employee's regular salary and is 23 entitled to mileage and expenses, to be paid by the employing agency. 24 SECTION 2. ENERGY POLICY COMMISSION STUDY - REPORT TO LEGISLATIVE 25 **COUNCIL.** The energy policy commission shall study, during the 2009-10 interim, issues 26 related to taxation of the energy industries in this state. The tax commissioner and the 27 department of commerce shall assist the commission in conducting this study. Notwithstanding 28 sections 57-38-57 and 57-39.2-23 and other confidentiality statutes, the tax commissioner shall 29 provide the department of commerce the information necessary to accomplish and effectuate 30 the intent of this section. Confidential information the department of commerce receives from the tax commissioner may not be divulged by the department of commerce unless the 31

1 information is in the aggregate and in a manner that will not divulge information specific to any

2 taxpayer. The commission shall report its findings and recommendations to the legislative

3 council before September 1, 2010. The study must include:

- An analysis of the use and effectiveness of existing income and sales tax
 incentives to promote energy development.
- An analysis of the traditional tax framework for lignite and electric generation
 projects to determine which incentives may be expanded to provide for new
 projects that allow for the future growth of the lignite industry.
- 9 3. Consideration of property taxation of wind farms based upon installed capacity and
 production.

SECTION 3. WATER RESOURCES STUDY - REPORT TO LEGISLATIVE COUNCIL.

12 The state water commission shall study, during the 2009-10 interim, the effect of energy

- 13 development on the state's water resources and make recommendations on methods to
- 14 minimize this impact and maximize the available water supply to support future energy growth.
- 15 The state water commission shall cooperate with the energy policy commission in conducting
- 16 this study. The water commission shall report its findings and recommendations to the
- 17 legislative council before September 1, 2010.

SECTION 4. LEGISLATIVE COUNCIL STUDY - LIVESTOCK FEEDING FACILITY

19 **PERMITTING PROCESS.** The legislative council shall consider studying, during the 2009-10

- 20 interim, issues related to the development of livestock feeding facilities and the use of
- 21 byproducts from biofuels production as a feedstock. The legislative council shall report its
- 22 findings and recommendations, together with any legislation required to implement the
- 23 recommendations, to the sixty-second legislative assembly.
