- 1 A BILL for an Act to amend and reenact section 53-06.1-12 of the North Dakota Century Code,
- 2 relating to gaming and excise taxes; and to provide an effective date.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. AMENDMENT.** Section 53-06.1-12 of the North Dakota Century Code is 5 amended and reenacted as follows:

6	53-0	06.1-12. Gaming and excise taxes - Exception - Deposits and allocations.
7	1.	A gaming tax is imposed on the total adjusted gross proceeds earned by a licensed
8		organization in a quarter and it must be computed and paid to the attorney general
9		on a quarterly basis on the tax return. This tax must be paid from adjusted gross
10		proceeds and is not part of the allowable expenses. The tax rates are:
11		a. On adjusted gross proceeds not exceeding two hundred thousand dollars, a
12		tax of five percent.
13		b. On adjusted gross proceeds exceeding two hundred thousand dollars but not
14		exceeding four hundred thousand dollars, a tax of ten percent.
15		c. On adjusted gross proceeds exceeding four hundred thousand dollars but not
16		exceeding six hundred thousand dollars, a tax of fifteen percent.
17		d. On adjusted gross proceeds exceeding six hundred thousand dollars, a tax of
18		twenty percent.
19	2.	Except as provided in subsection 3, in addition to any other tax provided by law
20		and in place of sales or use taxes, there is imposed an excise tax of four and
21		one half percent on the gross proceeds from the sale at retail of pull tabs and three
22		percent on the gross proceeds from the sale at retail of bingo cards to final users.
23		This includes pull tabs or bingo cards provided to a player in exchange for

1		redeemed winning pull tabs or bingo cards. The tax must be paid to the attorney	
2		general when tax returns are filed.	
3	<del>3.</del>	For organizations whose gross proceeds of pull tabs do not exceed four thousand	
4		dollars per calendar quarter, no excise tax may be imposed on the gross proceeds	
5		from the sale at retail of pull tabs to final users.	
6	<del>4.</del>	Except as provided in subsection $\frac{5}{2}$ , the state treasurer shall deposit gaming and	
7		excise taxes, monetary fines, and interest and penalties collected in the general	
8		fund in the state treasury.	
9	<del>5.</del> <u>3.</u>	The state treasurer shall deposit three percent of the total taxes, less refunds,	
10		collected under this section into a gaming and excise tax allocation fund. Pursuant	
11		to legislative appropriation, moneys in the fund must be distributed quarterly to	
12		cities and counties in proportion to the taxes collected under this section from	
13		licensed organizations conducting games within each city, for sites within city	
14		limits, or within each county, for sites outside city limits. If a city or county	
15		allocation under this subsection is less than two hundred dollars, that city or county	
16		is not entitled to receive a payment for the quarter and the undistributed amount	
17		must be included in the total amount to be distributed to other cities and counties	
18		for the quarter.	
19	SEC	CTION 2. EFFECTIVE DATE. This Act is effective for taxable events occurring after	
20	June 30, 2009.
