## POINT OF PERSONAL PRIVILEGE

**REP. BOUCHER:** Mr. Speaker: I rise on a point of personal privilege.

May we take this opportunity, Mr. Speaker to thank the Gospel Tabernacle Church Choir for joining us in today's celebration of Martin Luther King, Jr. Day.

Dr. King was a great American and an exemplary member of our human family. We all appreciate what he accomplished for mankind.

## POINT OF PERSONAL PRIVILEGE

**REP. CARLSON:** Mr. Speaker: I rise on a point of personal privilege.

## REQUEST

**REP. CARLSON REQUESTED** that his remarks be printed in the Journal, which request was granted.

There will be thousands of words said in tribute to Martin Luther King Jr. today, and they will all be fine words, and I suppose I could try to add some words of my own but I believe no amount of words today will mean near as much as the four word Barak Obama will say tomorrow as he places his hand on President Lincoln's bible and says, "I do solemnly swear".

This country is a long way from where it used to be. When we were kids, we memorized the Gettysburg Address. Many of our soldiers died on the battlefield because they were concerned that slavery was wrong, so this started way before Martin Luther King. The Gettysburg Address simply states: Four score and seven years ago our fathers brought forth on this continent, a new nation, conceived in Liberty, and dedicated to the proposition that all men are created equal.

Now we are engaged in a great civil war, testing whether that nation, or any nation so conceived and so dedicated, can long endure. We are met on a great battle-field of that war. We have come to dedicate a portion of that field, as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this.

But, in a larger sense, we can not dedicate - we can not consecrate - we can not hallow - this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract. The world will little note, nor long remember what we say here, but it can never forget what they did here. It is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced. It is rather for us to be here dedicated to the great task remaining before us - that from these

honored dead we take increased devotion to that cause for which they gave the last full measure of devotion - that we here highly resolve that these dead shall not have died in vain - that this nation, under God, shall have a new birth of freedom - and that government of the people, by the people, for the people, shall not perish from the earth. November 19, 1963. We shall remember the significance of these days.
