**SCR 4015:** A concurrent resolution directing the Industrial Commission to conduct a study of the economic impacts of proposed federal, regional, and state carbon cap and trade systems, including the Minnesota Next Generation Energy Act of 2007.

Was read the first time and referred to the **Natural Resources Committee**.

**SCR 4026:** A concurrent resolution commemorating the 100th anniversary of the Boy Scouts of America.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

**SCR 4027:** A concurrent resolution directing the Legislative Council to study the leasing of state lands.

Was read the first time and referred to the **Education Committee**.

**SCR 4028:** A concurrent resolution directing the Legislative Council to study the charitable gaming laws to determine whether the laws regarding taxation, limitations, enforcement, conduct, and play of charitable gaming are fair, adequate, and appropriate.

Was read the first time and referred to the **Judiciary Committee**.

**SCR 4032:** A concurrent resolution to create and enact a new section to article III of the Constitution of North Dakota, relating to vote requirements for local ordinances or initiated laws imposing requirements for supermajority votes; and to provide an effective date.

Was read the first time and referred to the **Constitutional Revision Committee**.
