## REMARKS OF ARIANA WALKER, MISS NORTH DAKOTA OUTSTANDING TEEN

Good afternoon ladies and gentlemen of the legislature! I am so grateful to have the opportunity to speak to you today, not just as Miss North Dakota's Outstanding Teen, but as a teenager concerned about the issues facing youth today.

So, despite the crown and sash, please do keep in mind that I am just a teenager who happens to have a passion for her community and platform.

My past years participating in pageants have been nothing short of amazing. Just this year, I have helped raise funds for the Make a Wish Foundation and The Children's Miracle Network. During the summer, I kept myself busy as a volunteer at the Buddy Walk for Downs Syndrome and the Dakota Kid's Cancer Ride Race for a Cure. I also had the pleasure of speaking at numerous Charles Hall benefits, including being their guest speaker at the annual Angel's Tea.

Through my journeys I have met some of the most influential and inspiring members of this community and for that I am truly blessed.

I am here today to briefly address some of the youth issues I know have come up during this session and have personally caught my attention. In one month, I will be 18. At this point, I can look back and say I have learned a few things.

First, 14 was way too young to start driving. In fact, in most states you can't drive until you are 16, which I believe to be a more mature age. In a report filed last year, the ND Department of Transportation said drivers 17 and younger accounted for 21% of fatal crashes in the past 6 years. Sure, when I was 14 I would do anything to get behind the wheel, but that didn't mean that I was ready. Truth be told, I made my fair share of mistakes during my first year with my license.

Plus, with cell phones and ipods becoming more common, teens can get distracted. Even I catch myself texting at a stoplight or shuffling through songs between stop signs. As much of a convenience as these technologies have become, they have proven time and time again to be hazardous on the roads, especially when streets are as icy as they have been this winter.

These issues, though very important, are not the reason I stand before you today with the title I presently have. Two years ago, I spoke at the Capitol for the 25th Anniversary of Students Against Destructive Decisions.

Last year I served on a Town Hall Meeting panel with Attorney General Wayne Stenehjem and First Lady Mikey Hoeven. This year, I have and will continue to speak at local middle schools addressing the issue that has North Dakota ranked #1 in the nation since 2005.

This issue, and my platform, is underage binge drinking.

Over the past 3 years, I have found that choosing my friends carefully is one way to avoid alcohol in middle school and high school. Keeping busy with classes, school activities, church and a job make it easier to say "no" to drugs and alcohol.

But there is no "magic bullet" or easy way around it. Research shows that it's a combination of things, such as: education, self-esteem, parental support, and involvement with friends, school, church and community that make the difference.

Unfortunately, parent involvement can have a negative effect. A majority of teenagers will tell you that it's easy to obtain alcohol from parents, whether they are providing it to the minors or the minors are stealing it from open liquor cabinets. They would also tell you that it is not hard to find a place to go where parents are either willingly hosting a party or unaware the behavior is taking place.

Recently, during WDA basketball weekend, 35 adults and 11 juveniles were arrested. Most of the charges were "delivery of alcohol to minors" or "minor in possession or consumption."

I'm shocked at how many parents don't check up on their teenagers when they aren't at home. And calling kids on their cell phones is ridiculous; they could be anywhere doing anything! Here is another case where cell phones, though convenient, can be dangerous.

I would like to ask you to please keep this important issue in mind when dealing with matters of underage and binge drinking this legislative session.

Alcohol is dangerous, and binge drinking can lead to death.

It is all too common that today's youth associate parties with alcohol, and as Miss North Dakota's Outstanding Teen, I am always working to change that. I'm not perfect, but by speaking with middle school students, my goal is to stop binge drinking before it starts.

Thank you so much for your time and for allowing me to be a part of this Legislative Assembly.

I commend you all on the great work you are doing for the State of North Dakota.

It has been an honor and a blessing being here today. Thank you.

- (2) The weed board files a plan with the commissioner detailing the manner in which and the time within which the funds are to be expended.
- b. Notwithstanding any other law, a county or a city weed board may accept a grant under this subsection and implement a plan, approved by the commissioner, for the control of invasive species within its jurisdiction.
3. In addition to grant funds available from the commissioner, a county or a city weed board may accept funds from any other source to control invasive species within its jurisdiction.
4. For purposes of this section, an invasive species means a plant species that has been introduced into this state and which the North Dakota state university extension service determines has caused or is likely to cause:
  - a. Economic harm;
  - b. Environmental harm; or
  - c. Harm to human health."
