**MEMORIAL ADDRESS BY DEPUTY ATTORNEY GENERAL THOMAS L. TRENBEATH**

Senators, honored guests, ladies and gentlemen, I am deeply appreciative of this opportunity to continue the tradition, here in the North Dakota Senate, of honoring the memory of our departed members. With your permission I will speak as if I were still a member of this august body, as my service here has been one of the highlights of my life.

It is my belief that there is not one member in attendance, from the newly elected to those of emeritus status who hasn't considered and been comforted by the knowledge that some day, soon or late, his or her name will be spoken in honor and remembrance in the well of this place--this Senate Chamber. For no matter the length of service, whether one term forty years ago or ten terms commencing forty years ago, the bonds of brotherhood and sisterhood are forged in the discussions and debates of the day and, though the issues may change the goal has remained the same: service to the citizens of this Great State of North Dakota, service that is given its due accord and honor on this day.

With service often times comes sacrifice. So it is with membership in this body. Each of the gentlemen we honor and remember this day heard the call, successfully sought the office, and acquitted himself to the very best of his abilities. With that answered call came the attenuating burden of sacrifice. They left their business endeavors, their friends, their daily and comfortable routines to throw themselves into the crucible of public service. In addition, many left family behind at a time when roads and vehicles would not easily allow the weekend

commute many embark on today. Absence from spouse and children was, undoubtedly, the greatest burden. And that burden was felt equally, or perhaps to a greater extent, at home.

And I ask you to consider the extraordinary service these gentlemen rendered to this state: Three of those memorialized as Senators, also served in the North Dakota House of Representatives; Senator Thompson also chaired the Workers' Compensation Commission; Senator Tweten served on the North Dakota Board of Higher Education; and Senator Hagen was Labor Commissioner and Lieutenant Governor. This is service personified.

The quality of service, the burden of sacrifice: these are observations that can be made of these honored gentlemen merely from the fact that they were here. Unfortunately, I am able to make more specific observations with regard to two of these men. I say "unfortunately" as my knowledge comes from having served with these two which is, to me, an indication of the untimeliness of their passing.

When I was a freshman member of this body, the then Majority Leader, Senator Gary Nelson, asked Senator Ken Solberg to be my mentor. Senator Solberg accepted the responsibility as I came to learn he accepted all of life's challenges (and I certainly was one of his)--with gusto. Ken was a man for whom "grey" was not in the spectrum. Black or white would do just fine. I quickly learned that I never had to discern where Ken was coming from, what he was thinking, what his opinions were, or where he was heading. All I had to do was ask him; or not ask him for that matter. Senator Solberg always came straight at you. No subterfuge or artifice. What you saw, and heard, was what you got and what he meant. There were few things the good Senator from Rugby objected to more than protein on a plate that hadn't previously had cloven hooves and four stomachs. You see, Ken was a cattleman. More than once, at banquet events when seeing that chicken was being served the good Senator would make the following observation, "something on this plate didn't walk on four legs." That was Ken.

Then there is Senator Dick Brown. To overwork a cliché, if you look up the word "gentleman" in the dictionary you'll find a picture of Dick Brown. During the course of our common tenure, I dare say, Senator Brown and I disagreed more than we were in accord. For two Senators of a common party it was, at times, as if we spoke different languages. But politics aside, there was something about our personalities that spawned a lasting friendship. I have never known Senator Brown to be rude, brash, or even discourteous. Dick understood the fine art of making a point without offending. Many times, subsequent to our service in this chamber, I would travel to Fargo to visit family, and run into him at church on Sunday. His smile of recognition and extended right hand always immediately took us back to our shared history in this place.

The strongest bonds of comradeship are forged in the heat of common endeavors--college; grad school; basic training; and, yes, public service. So it was with Ken, Dick, and me. So it undoubtedly has been with some of you and those we remember, today.

Many of you will have specific memories of others whose service to this body we celebrate today. Some may be remembered as humorous, boisterous, or quietly competent. This is not a body of just one stripe. We are a coat of many colors and each of the honored, departed members personified one or more of the attributes necessary to guide North Dakota through the challenges presented.

In closing I am reminded of a Vachel Lindsay poem. I'll close with a portion of "Rain."

Only boys keep their cheeks dry.  
Only boys are afraid to cry.  
Men thank God for tears,  
Alone with the memory of their dead,  
The memory of these years.
