1 A BILL for an Act to amend and reenact subsection 1 of section 23-09.3-01.1 and subsection 1

2 of section 23-16-01.1 of the North Dakota Century Code, relating to the moratorium on

3 expansion of basic care bed capacity and the moratorium on expansion of long-term care bed

4 capacity; and to provide for a legislative council study.

## 5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 SECTION 1. AMENDMENT. Subsection 1 of section 23-09.3-01.1 of the North Dakota
7 Century Code is amended and reenacted as follows:

8	1.	Basi	c care beds may not be added to the state's licensed bed capacity during the
9		perio	od between August 1, <del>2007</del> 2009, and July 31, <del>2009</del> 2011, except when:
10		a.	A nursing facility converts nursing facility beds to basic care;
11		b.	An entity demonstrates to the state department of health and the department
12			of human services that basic care services are not readily available within a
13			designated area of the state or that existing basic care beds within a fifty-mile
14			radius have been occupied at ninety percent or more for the previous twelve
15			months. In determining whether basic care services will be readily available if
16			an additional license is issued, preference may be given to an entity that
17			agrees to any participation program established by the department of human
18			services for individuals eligible for services under the medical assistance
19			program under title XIX of the Social Security Act [42 U.S.C. 1396 et seq.]; or
20		C.	If the state department of health and the department of human services grant
21			approval of new basic care beds to an entity, the approved entity shall license
22			the beds within forty-eight months from the date of approval.
23	SEC	CTION	<b>2. AMENDMENT.</b> Subsection 1 of section 23-16-01.1 of the North Dakota
24	Century Code is amended and reenacted as follows:

11. Notwithstanding sections 23-16-06 and 23-16-10, except when a facility reverts2basic care beds to nursing facility beds, nursing facility beds may not be added to3the state's licensed bed capacity during the period between August 1, 2007 2009,4and July 31, 2009 2011. A nursing facility may not convert licensed nursing bed5capacity to basic care bed capacity or convert basic care beds back to nursing6facility beds more than one time in a twelve-month period if the beds have been7licensed as basic care.

8 SECTION 3. LEGISLATIVE COUNCIL STUDY-LONG TERM CARE. During the 9 2009-10 interim, the legislative council shall study the state's long-term care system including 10 capacity, geographical boundaries for determining capacity, the need for home and 11 community-based services, a methodology to identify areas of the state which are in need of 12 additional skilled nursing facility beds, access, workforce, reimbursement, and payment 13 incentives. The legislative council shall report its findings and recommendations, together with 14 any legislation required to implement the recommendations, to the sixty-second legislative 15 assembly.
