- 1 A BILL for an Act to amend and reenact sections 37-17.1-06 and 37-17.1-07 of the North
- 2 Dakota Century Code, relating to the department of emergency services division of homeland
- 3 security and local and regional emergency management organizations.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Section 37-17.1-06 of the North Dakota Century Code is

6 amended and reenacted as follows:

37-17.1-06. State division of homeland security.

- 8 The division of homeland security must have professional, technical, secretarial, 1. 9 and clerical employees as necessary for the performance of its functions. The 10 director of the division shall fix the compensation of the staff in conformity with 11 state merit system regulations and may make such expenditures within the 12 appropriations therefor, or from other funds made available to the director for 13 purposes of emergency management, as may be necessary to carry out the 14 purposes of this chapter. 15 2. The division of homeland security shall prepare and maintain a state disaster plan
- 15 2. The division of homeland security shall prepare and maintain a state disaster plan
 16 and keep it current, which plan may include provisions for:
- 17 a. Averting or minimizing the injury and damage caused by disasters or18 emergencies.
- 19 b. Prompt and effective response to a disaster or emergency.
- 20 c. Emergency relief.
- 21 d. Identification of areas particularly vulnerable to a disaster or emergency.
- e. Recommendations for zoning, building, and other land use controls, safety
- 23 measures for securing mobile homes or other nonpermanent or
- 24 semipermanent structures, and other mitigation and preparedness measures.

19		business, labor, industry, agriculture, civic, and volunteer organizations and			
20		community leaders. In advising local and regional emergency management			
21		organizations, the division shall encourage them also to seek advice from these	ŀ

23	5.	State disaster or emergency plans or any parts thereof have the force of law up	on

2		plans.
3	d.	Coordinate state or state and federal assistance to local and regional
4		emergency management organizations.
5	e.	Establish and operate or assist local and regional emergency management
6		organizations to establish and operate training programs and programs for
7		emergency public information.
8	f.	Make surveys of industries, resources, and facilities, within the state, both
9		public and private, as are necessary to carry out the purposes of this chapter.
10		The use of sensitive and proprietary logistical data submitted to the state in
11		confidence by individual industries and suppliers must be accorded full
12		confidentiality and will be released only in aggregate form.
13	g.	Plan and make arrangements for the availability and use of any private
14		facilities, services, and property, and, if necessary and if in fact used,
15		coordinate payment for that use under terms and conditions agreed upon.
16	h.	Establish access to a register of persons with types of training and skills
17		important in prevention, mitigation, preparedness, response, and recovery.
18	i.	Establish access to a register of equipment and facilities available for use in a
19		disaster or emergency.
20	j.	Prepare, for issuance by the governor, executive orders, proclamations, and
21		guidance as necessary or appropriate in managing a disaster or emergency.
22	k.	Coordinate and may enter agreements with the federal government and any
23		public or private agency or entity in achieving any purpose of this chapter and
24		in implementing programs for disaster mitigation, preparation, response, and
25		recovery.
26	١.	Be the state search and rescue coordinating agency, establish access to a
27		register of search and rescue equipment and personnel in the state, and plan
28		for its effective utilization.
29	m.	Do other things necessary, incidental, or appropriate for the implementation of
30		this chapter.

SECTION 2. AMENDMENT. Section 37-17.1-07 of the North Dakota Century Code is
 amended and reenacted as follows:

37-17.1-07. Local or regional emergency management organizations.

- All areas of the state are within the jurisdiction of and must be served by the
 division of homeland security and by a local <u>or regional</u> emergency management
 organization.
- 2. Each county shall maintain an emergency management organization which that
 serves the entire county or must be a member of a regional emergency
 <u>management organization that serves more than one county</u>.
- Each city shall provide an emergency management organization of its own, or it
 shall participate in the countywide emergency management organization. Each
 governing board of a city shall make its determination on the basis of the city's
 emergency management requirements, hazards, capabilities, and resources. If a
 city provides an emergency management organization of its own, the city and
 county shall coordinate the city and county emergency plans.
- 164.The mayor of or the president of the board of city commissioners in a city with an17emergency management organization and the chairman of the board of county18commissioners shall notify the division of homeland security of the manner in19which the city and the county are providing or securing emergency management20activities, identify each individual who will coordinate the activities of the local21emergency management organization, and furnish additional information relating22thereto as the division requires.
- 5. Each local <u>or regional</u> emergency management organization shall prepare and
 keep current a local disaster or emergency operational plan for its area.
- The Each local or regional emergency management organization shall prepare
 and distribute to all appropriate officials in written form a clear and complete
 statement of the disaster or emergency responsibilities of their local agencies and
 officials.
