6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Section 15-70-01 of the North Dakota Century Code is
 amended and reenacted as follows:
- 9 **15-70-01. Definitions.** In As used in this chapter, unless the context otherwise 10 requires:
- "Full-time" means that a student is enrolled for at least twenty-four semester hours
 during an academic year.
 - 2. "Nonbeneficiary student" means a resident of North Dakota who is enrolled in a tribally controlled community college but is not an enrolled member of a federally recognized Indian tribe.
- 16 2. 3. "Tribally controlled community college" means an institution of higher education in
 17 this state which is formally controlled or has been formally sanctioned or chartered
 18 by the governing body of an Indian tribe, or any combination of federally
 19 recognized Indian tribes.
- SECTION 2. AMENDMENT. Section 15-70-04 of the North Dakota Century Code is amended and reenacted as follows:
- 15-70-04. Submission of grant application Distribution of grants. In order to qualify for a grant under this chapter, an institution shall submit an application in the manner required by the state board of higher education. If an application is approved, the board shall

- 1 distribute to each tribally controlled community college, during each year of the biennium, four
- 2 <u>five</u> thousand five hundred eighty-one dollars for each nonbeneficiary student on a full-time
- 3 equivalent basis. If the amount appropriated is insufficient, the board shall distribute a prorated
- 4 amount per nonbeneficiary student on a full-time equivalent basis.
 - **SECTION 3. AMENDMENT.** Section 15-70-05 of the North Dakota Century Code is amended and reenacted as follows:
- 7 15-70-05. Reporting by recipient institutions - Failure to report. Each institution 8 receiving a grant under this chapter shall annually provide to the state board of higher 9 education an accurate and detailed account of submit to the legislative council, at the time and 10 in the manner directed by the council, a report detailing the expenditures of the grant funds 11 received by the institution under this chapter and, a copy of the institution's latest audit report 12 and documentation of the enrollment status and ethnic status of each student on whose 13 account financial assistance under this chapter is sought, and any other information requested 14 by the council. Any institution that fails to meet the requirements of this section is ineligible to 15 receive future grants under this chapter.
 - **SECTION 4. AMENDMENT.** Section 57-51.1-07.4 of the North Dakota Century Code is amended and reenacted as follows:
 - **57-51.1-07.4.** Separate allocation of state share of collections from reservation development. Notwithstanding any other provision of law, the state treasurer shall transfer to the permanent oil tax trust fund the first seven hundred thousand dollars of the state's share of tax revenues under this chapter from oil produced from wells within the exterior boundaries of the Fort Berthold Reservation drilled and completed after June 30, 2007 2009.
 - **SECTION 5. APPROPRIATION.** There is appropriated out of any moneys in the permanent oil tax trust fund in the state treasury, not otherwise appropriated, the sum of \$700,000, or so much of the sum as may be necessary, to the state board of higher education for the purpose of providing grant assistance to tribally controlled community colleges, for the biennium beginning July 1, 2009, and ending June 30, 2011.
