**ENGROSSED SENATE BILL NO. 2350**

1 A BILL for an Act to provide for the creation of an ethanol council; to amend and reenact  
2 sections 4-24-09 and 4-24-10 of the North Dakota Century Code, relating to the agricultural  
3 commodity assessments funds and a report to the legislative assembly; to provide a penalty;  
4 and to provide a continuing appropriation.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. Definitions.** As used in sections 1 through 13 of this Act:

- 7 1. "Council" means the North Dakota ethanol council.  
8 2. "Producer" means the owner of a facility that is located in this state and which  
9 produces annually more than one million gallons of agriculturally derived  
10 denatured ethanol that is suitable for blending with a petroleum product for use in  
11 internal combustion engines.

12 **SECTION 2. Council - Membership - Election - Term.**

- 13 1. The council consists of one individual appointed by each producer.  
14 2. Each member of the council must be a resident of this state and employed by a  
15 producer.  
16 3. The term of each member is four years and begins on April first following the  
17 members' appointment. The terms must be staggered by the council to ensure  
18 that an approximately equal number of appointments expire each year.  
19 4. If at any time during a member's term the member ceases to possess any of the  
20 qualifications provided by this section, the member's office is deemed vacant and  
21 the producer who appointed that member shall appoint another qualified individual  
22 for the remainder of the term.

- 1           5. A member may not serve more than two consecutive terms. If an individual is  
2                     appointed to complete a vacancy, that service is not counted as a term for  
3                     purposes of this section unless the duration of that service exceeds one year.

4           **SECTION 3. Election of chairman - Meetings.**

- 5           1. Annually, the council shall elect one member to serve as the chairman.  
6           2. The chairman shall call all meetings of the council and shall call a special meeting  
7                     of the council within seven days when petitioned to do so by three council  
8                     members.

9           **SECTION 4. Council members - Compensation.** Each member of the council is  
10 entitled to receive compensation in the amount established by the council, but not exceeding  
11 one hundred thirty-five dollars per day plus reimbursement for expenses as provided by law for  
12 state officers if the member is attending meetings or performing duties directed by the council.

13           **SECTION 5. Council - Powers.**

- 14           1. The council may:  
15                     a. Expend moneys collected pursuant to sections 1 through 13 of this Act for its  
16                     administration;  
17                     b. Employ, bond, and compensate necessary personnel;  
18                     c. Accept gifts, grants, and donations of money, property, and services to carry  
19                     out sections 1 through 13 of this Act;  
20                     d. Contract with any person for any purpose permitted under sections 1 through  
21                     13 of this Act;  
22                     e. Sue and be sued; and  
23                     f. Do all things necessary and proper to enforce and administer sections 1  
24                     through 13 of this Act.  
25           2. The council may not engage in a commercial business enterprise.

26           **SECTION 6. Council - Duties.**

- 27           1. The council shall determine the uses to which any moneys raised under sections 1  
28                     through 13 of this Act may be expended. The uses may include:  
29                     a. The funding of research, education programs, promotion, and market  
30                     development efforts; and

1            b. The support of state, regional, national, and international entities that promote  
2            ethanol utilization.

3            2. The council shall develop and disseminate information regarding the purpose of  
4            the ethanol assessment and ways in which the assessment benefits producers.

5            **SECTION 7. Assessment.** An assessment at the rate of three one-hundredths of one  
6            cent per gallon is imposed upon all ethanol produced and sold in this state.

7            **SECTION 8. Calculation of assessment - Records.**

8            1. Each producer shall calculate the assessment imposed by section 7 of this Act at  
9            the time of sale.

10           2. Each producer shall keep documents regarding its ethanol production and sales  
11           for a period of three years. The producer shall make these records available to the  
12           council for examination upon request.

13           3. No later than thirty days after the conclusion of each calendar quarter, each  
14           producer shall file with the council a report stating the quantity of ethanol produced  
15           and the quantity sold during the preceding quarter.

16           **SECTION 9. Submission of assessments - Civil penalty.**

17           1. Each producer shall forward to the council all assessments imposed by section 7  
18           of this Act within thirty days after the conclusion of each calendar quarter.

19           2. If a producer fails to submit the assessments as required by this section, the  
20           council may impose a penalty equal to ten percent of the amount due, plus interest  
21           at the rate of twelve percent per annum from the due date.

22           **SECTION 10. Refund of assessment.**

23           1. To receive a refund of any assessment paid in accordance with sections 1 through  
24           13 of this Act, a producer shall submit to the council a written request for a refund  
25           application within sixty days after the conclusion of each calendar quarter.

26           2. The producer shall complete the refund application and return the application to  
27           the council, together with a record of the assessment collected, within ninety days  
28           after the conclusion of each calendar quarter. The council shall then refund the  
29           net amount of the assessment that had been collected.

30           3. If a request for a refund is not submitted to the council within the prescribed time  
31           period, the producer is presumed to have agreed to the assessment.

1 lentil council, the North Dakota barley council, the North Dakota soybean council, the North  
2 Dakota corn utilization council, the North Dakota beekeepers association, the North Dakota  
3 turkey federation, the North Dakota milk marketing board, the North Dakota dairy promotion  
4 commission, the North Dakota state wheat commission, and the North Dakota beef commission  
5 must file a uniform report at a public hearing before the standing agriculture committee of each  
6 house of the legislative assembly. The presiding officer of each house of the legislative  
7 assembly may direct that the reports be filed with some other standing committee of that house.  
8 Each report must contain a summary of the activities of the commodity group during the current  
9 biennium, a single-page uniform statement of revenues and expenditures for the next biennium.  
10 Each report, except the reports of the North Dakota beekeepers association and the North  
11 Dakota turkey federation, must also include a state auditor's report on the commodity group's  
12 single-page uniform statement of revenues and expenditures for the previous two fiscal years.
