- 1 A BILL for an Act to create and enact two new sections to chapter 54-60 of the North Dakota
- 2 Century Code, relating to the promotion of sustainably grown agricultural commodities; and to
- 3 provide an effective date.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1.** A new section to chapter 54-60 of the North Dakota Century Code is
- 6 created and enacted as follows:

7 Sustainably grown in North Dakota - Application - Logo - Promotion of

8 commodities.

9	<u>1.</u>	The department of commerce shall implement a program to promote agricultural
10		commodities that are sustainably grown in North Dakota.
11	<u>2.</u>	A producer may apply to the department and upon demonstrating that the
12		producer's growing practices with respect to a particular commodity meet the
13		department's established criteria for sustainability, the department shall authorize
14		the producer to label and market the commodity as being sustainably grown in
15		North Dakota.
16	<u>3.</u>	The department shall develop and make available for the use of authorized
17		producers a logo indicating that the commodity is sustainably grown in North
18		Dakota. The department shall actively support and promote the sale and use of
19		products identified as sustainably grown in North Dakota.
20	<u>4.</u>	The department may establish and charge producers a fee for participating in the
21		program. The department shall forward all fees collected under this section to the
22		state treasurer for deposit in the general fund.
23	<u>5.</u>	For purposes of this section, "sustainably grown" means that a crop is grown using
24		research-based practices that result in:

15			designee;

17		<u>d.</u>	The director of the North Dakota state university agricultural experiment

25		<u>a.</u>	Examine the concept of sustainability with respect to conventional farming					
26			practices and modern technology-based production practices;					
27		<u>b.</u>	Examine production practices that are efficient and able to meet current and					
28			future global food and nutritional needs;					
29		<u>C.</u>	Examine production practices that promote increased efficiencies in resource					
30			use, improve human health through access to safe and nutritious food, and					
31			enhance economic opportunities for individual producers;

1		d. Explore metric evaluations to measure the attainment, maintenance, and
2		certification of sustainability; and
3		e. Advise the department regarding the development of a sustainability
4		certification program and the marketing and packaging of products containing
5		the certification.
6	<u>3.</u>	Each legislative member of the committee is entitled to receive per diem
7		compensation in the amount established by subsection 1 of section 54-03-20 plus
8		reimbursement for expenses as provided by law for state officers if the member is
9		attending meetings or performing duties directed by the committee.
10	SE	CTION 3. EFFECTIVE DATE. This Act becomes effective on July 1, 2011.
