- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
- 2 governor, and to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota
- 3 Century Code, relating to the salaries of the governor and lieutenant governor and the office.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

**SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the office of the governor for the purpose of defraying the expenses of the office of the governor, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

1	SECTION 2. APPROPRIATION - AUTHORIZATION - GOVERNOR'S OFFICE. In
2	addition to the amounts appropriated to the governor's office in section 1 of this Act, there is
3	appropriated any additional income from federal or other funds which may become available to
4	the agency for the biennium beginning July 1, 2009, and ending June 30, 2011.
5	SECTION 3. AMENDMENT. Section 54-07-04 of the North Dakota Century Code is
6	amended and reenacted as follows:
7	<b>54-07-04.</b> Salary of governor. The annual salary of the governor is ninety six one
8	hundred five thousand ene hundred eighty three and thirty-four dollars through June 30, 2008
9	2010, and one hundred ten thousand thirty-one two hundred eighty-five dollars thereafter.
10	SECTION 4. AMENDMENT. Section 54-08-03 of the North Dakota Century Code is
11	amended and reenacted as follows:
12	54-08-03. Salary of lieutenant governor. The annual salary of the lieutenant
13	governor is seventy four six eighty one thousand five hundred sixty eight thirty-eight dollars
14	through June 30, <del>2008</del> <u>2010</u> , and <del>seventy-seven</del> <u>eighty-five</u> thousand six hundred <del>fifty-five</del>
15	fifteen dollars thereafter.
