- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the agriculture
- 2 commissioner; to amend and reenact section 4-01-21 of the North Dakota Century Code
- 3 relating to the salary of the agriculture commissioner; and to provide for transfers.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the agriculture commissioner for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

23 SECTION 2. ESTIMATED INCOME - ENVIRONMENT AND RANGELAND

PROTECTION FUND. The estimated income line item in section 1 of this Act includes the sum

1 of \$3,529,556 or so much of the sum as may be available, from the environment and rangeland 2 protection fund for the purpose of defraying the expenses of various agriculture department 3 programs, for the biennium beginning July 1, 2009, and ending June 30, 2011. 4 SECTION 3. ANHYDROUS AMMONIA STORAGE INSPECTION FUND. The 5 estimated income line item in section 1 of this Act includes the sum of \$40,000, or so much of 6 the sum as may be available, from the anhydrous ammonia storage inspection fund for the 7 purpose of defraying the expenses of regulating anhydrous ammonia storage facilities, for the 8 biennium beginning July 1, 2009, and ending June 30, 2011. 9 SECTION 4. ESTIMATED INCOME - GAME AND FISH FUND. The estimated income 10 line item in section 1 of this Act includes the sum of \$968,800, or so much of the sum as may 11 be necessary, from the game and fish department operating fund for the purpose of defraying 12 the expenses of various agriculture department programs for the biennium beginning July 1, 13 2009, and ending June 30, 2011. 14 **SECTION 5. ONE-TIME FUNDING.** The following amounts reflect the one-time funding items approved by the sixtieth legislative assembly for the 2007-09 biennium. 15 16 One-time Funding Description 2007-09 2009-11 17 Animal tracking database \$90,836 18 Total general fund \$90,836 19 **SECTION 6. AMENDMENT.** Section 4-01-21 of the North Dakota Century Code is 20 amended and reenacted as follows: 21 **4-01-21.** Salary of agriculture commissioner. The annual salary of the agriculture 22 commissioner is seventy-eight eighty-five thousand five eight hundred ninety-nine thirty dollars 23 through June 30, 2008 2010, and eighty-one ninety thousand seven one hundred forty-three 24 twenty-two dollars thereafter.
