## HOUSE BILL NO.

1 A BILL for an Act to amend and reenact subsection 7 of section 39-06.1-10 of the North Dakota  
2 Century Code, relating to the suspension of operator's licenses.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Subsection 7 of section 39-06.1-10 of the North Dakota  
5 Century Code is amended and reenacted as follows:

- 6 7. The period of suspension imposed for a violation of section 39-08-01 or equivalent  
7 ordinance is:
- 8 a. Ninety-one days if the operator's record shows the person has not violated  
9 section 39-08-01 or equivalent ordinance within the five years preceding the  
10 last violation ~~and the violation was for an alcohol concentration of at least~~  
11 ~~eight one-hundredths of one percent by weight and under eighteen~~  
12 ~~one-hundredths of one percent by weight.~~
- 13 b. One hundred eighty days if the operator's record shows the person has not  
14 violated section 39-08-01 or equivalent ordinance within five years preceding  
15 the last violation and the violation was for an alcohol concentration of at least  
16 eighteen one-hundredths of one percent by weight.
- 17 c. Three hundred sixty-five days if the operator's record shows the person has  
18 once violated section 39-08-01 or equivalent ordinance within the five years  
19 preceding the last violation ~~and the violation is for an alcohol concentration of~~  
20 ~~under eighteen one-hundredths of one percent by weight.~~
- 21 d. Two years if the operator's record shows the person has at least once violated  
22 section 39-08-01 or equivalent ordinance within the five years preceding the  
23 last violation and the violation was for an alcohol concentration of at least  
24 eighteen one-hundredths of one percent by weight ~~or if the operator's record~~

- 1                   ~~shows the person has at least twice violated section 39-08-01 or equivalent~~  
2                   ~~ordinance within the five years preceding the last violation and the violation~~  
3                   ~~was for an alcohol concentration of at least eight one hundredths of one~~  
4                   ~~percent by weight and under eighteen one hundredths of one percent by~~  
5                   ~~weight.~~
- 6                   e.   Two years if the operator's record shows the person has at least twice  
7                   violated section 39-08-01 or equivalent ordinance within the five years  
8                   preceding the last violation.
- 9                   f.   Three years if the operator's record shows the person has at least twice  
10                  violated section 39-08-01 or equivalent ordinance within the five years  
11                  preceding the last violation and the violation is for an alcohol concentration of  
12                  at least eighteen one-hundredths of one percent by weight.
