<sup>2</sup> This amendment removes funding for a grant for a poet laureate, the same as the House version.

<sup>3</sup> This amendment removes funding for grants to art museums added by the Senate, the same as the House version.

<sup>4</sup> This amendment appropriates federal fiscal stimulus funds from the American Recovery and Reinvestment Act of 2009 for grants to arts organizations for salary support (\$175,000), grants to arts organizations for maintenance or expansion of current artistic contracts (\$80,000), and administrative support for new one-time grants (\$35,000). The House also included this funding.

<sup>5</sup> This amendment reduces general fund support for the Council on the Arts by 3 percent and increases funding from other funds by the same amount.

This amendment adds a section to allow the Council on the Arts to accept funding under the federal American Recovery and Reinvestment Act of 2009 for the 2009-11 biennium, the same as the House version.
