- 1 A BILL for an Act to create and enact a new section to chapter 54-59 of the North Dakota
- 2 Century Code, relating to powers of the information technology department; and to amend and
- 3 reenact sections 37-17.1-02.1, 54-23.2-01, and 57-40.6-12 of the North Dakota Century Code,
- 4 relating to state radio within the information technology department.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1.** A new section to chapter 54-59 of the North Dakota Century Code is 7 created:
- 8 <u>Division of state radio.</u> The information technology department must have a division
- 9 of state radio. The chief information officer shall appoint a separate director for the division.
- 10 The division director serves at the pleasure of the chief information officer. The chief
- 11 information officer shall fix the compensation of the division director within limits of legislative
- 12 appropriation.
- 13 **SECTION 2. AMENDMENT.** Section 37-17.1-02.1 of the North Dakota Century Code
- 14 is amended:
- 15 **37-17.1-02.1. Department of emergency services.** The department of emergency
- 16 services consists of must have a division of state radio and a division of homeland security.
- 17 The adjutant general is the director of the department. The adjutant general shall provide for
- 18 shared administration of both divisions. The division of homeland security consists of the state
- 19 emergency operations center section, the disaster recovery section, and the homeland security
- 20 section. The adjutant general shall appoint a separate director of each division. A The division
- 21 director serves at the pleasure of the adjutant general. The adjutant general shall fix the
- 22 compensation of a the division director within limits of legislative appropriation.
- 23 **SECTION 3. AMENDMENT.** Section 54-23.2-01 of the North Dakota Century Code is

- d. Periodically evaluate chapter 57-40.6 and recommend changes to the legislative council.
- 3. The committee may initiate and administer statewide agreements among the governing bodies of the local governmental units with jurisdiction over an emergency 911 telephone system to coordinate the procurement of equipment and services, fund the research, administration, and activities of the committee, and contract for the necessary staff support for committee activities.
