- 1 A BILL for an Act to provide for the certification of gravel pits and forage; to repeal section
- 2 63-01.1-12.2 of the North Dakota Century Code, relating to weed-free certification of gravel pits,
- 3 sand pits, and hay land; and to declare an emergency.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. Certification of gravel pits. For purposes of this section a "gravel pit" 6 includes any pit or surface area from which sand, gravel, aggregate, scoria, or other road 7 building material is removed. The agriculture commissioner shall inspect any gravel pit in this 8 state when requested to do so by the owner or lessee of the gravel pit. If the commissioner 9 inspects the pit between the twentieth day of June and the tenth day of July and determines 10 that the noxious weeds in the pit have been controlled as required by law, the commissioner 11 shall certify that the pit has been inspected and found to be in compliance with the noxious 12 weed laws of this state. A certification issued by the commissioner under this section is valid 13 until April first following the date of the inspection. 14 SECTION 2. Certification of forage - Compliance with noxious weed laws. The 15 agriculture commissioner shall inspect any land from which forage is to be harvested when 16 requested to do so by the owner or lessee of the land. If the commissioner inspects the land 17 within ten days before harvesting of the forage and determines that noxious weeds on the land 18 have been controlled as required by law, and if the commissioner returns upon completion of 19 the forage harvest and verifies that the harvested forage has been stored in an area that is in 20 compliance with the noxious weed laws of this state, the commissioner shall certify that the 21 forage has been harvested from and stored on land that is in compliance with the noxious weed 22 laws of this state.

SECTION 3. Certification of forage - Compliance with other standards. The

- 2 <u>within ten days before harvesting of the forage and determines that weeds on the land have</u>
- 3 been controlled in accordance with standards established by the North American weed
- 4 management association, and if the commissioner returns upon completion of the forage
- 5 harvest and verifies that the harvested forage has been stored in an area that is in compliance
- 6 with the standards established by the North American weed management association, the
- 7 commissioner shall certify that the forage has been harvested from and stored on land that is in
- 8 compliance with the standards established by the North American weed management
- 9 association.
- SECTION 4. Agents of the commissioner Designation Training. The agriculture
- 11 <u>commissioner may designate individuals to serve as agents of the commissioner for purposes</u>
- 12 of conducting the inspections permitted by this Act. To be designated as an agent, an
- 13 individual must:

- 14 1. Be a weed control officer;
- 15
  Be determined by the commissioner to have a level of education and experience
  sufficient to accurately perform the requested certifications; or
  - 3. At least once every thirty-six months, successfully complete a training program conducted by the commissioner.
- 19 **SECTION 5. REPEAL.** Section 63-01.1-12.2 of the North Dakota Century Code is 20 repealed.
- 21 **SECTION 6. EMERGENCY.** This Act is declared to be an emergency measure.
