1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;
2 and to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the
3 salary of the state treasurer.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the
6 funds as may be necessary, are appropriated out of any moneys in the general fund in the state
7 treasury not otherwise appropriated, and from special funds derived from federal funds and
8 other income, to the state treasurer for the purpose of defraying the expenses of that agency,
9 for the biennium beginning July 1, 2009, and ending June 30, 2011, as follows:

23 **SECTION 3. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is
24 amended and reenacted as follows:

1 **54-11-13. Salary of state treasurer.** The annual salary of the state treasurer is
