1 A BILL for an Act to amend and reenact section 54-59-05, 54-59-08, and 54-59-11 of the North  
2 Dakota Century Code, relating to powers and duties of the information technology department,  
3 required use of wide area network services and information technology plans.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 54-59-05 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7 **54-59-05. Powers and duties of department.** The department:

- 8 1. Shall provide, supervise, and regulate information technology of all executive  
9 branch state entities, excluding the institutions under the control of the board of  
10 higher education.
- 11 2. Shall provide network services in a way that ensures the network requirements of a  
12 single entity do not adversely affect the functionality of the whole network,  
13 facilitates open communications with the citizens of the state, minimizes the state's  
14 investment in human resources, accommodates an ever-increasing amount of  
15 traffic, supports rapid detection and resolution of problems, protects the network  
16 infrastructure from damage and security breaches, provides for the aggregation of  
17 data, voice, video, and multimedia into a statewide transport mechanism or  
18 backbone, and provides for the network support for the entity to carry out its  
19 mission.
- 20 3. May review and approve additional network services that are not provided by the  
21 department.
- 22 4. May purchase, finance the purchase, or lease equipment, software, or  
23 implementation services or replace, including by trade or resale, equipment or  
24 software as may be necessary to carry out this chapter. An agreement to finance

1 the purchase of software, equipment, or implementation services may not exceed a  
2 period of five years. The department shall submit any intended financing proposal  
3 for the purchase of software, equipment, or implementation services under this  
4 subsection, which is in excess of one million dollars, to the budget section of the  
5 legislative council or the legislative assembly before executing a financing  
6 agreement. If the budget section or the legislative assembly does not approve the  
7 execution of a financing agreement, the department may not proceed with the  
8 proposed financing arrangement. The department may finance the purchase of  
9 software, equipment, or implementation services only to the extent the purchase  
10 amount does not exceed seven and one-half percent of the amount appropriated to  
11 the department during that biennium.

12 5. Shall review requests for lease, purchase, or other contractual acquisition of  
13 information technology as required by this subsection. Each executive branch  
14 agency or institution, excluding the institutions under the control of the board of  
15 higher education, shall submit to the department, in accordance with guidelines  
16 established by the department, a written request for the lease, purchase, or other  
17 contractual acquisition of information technology. The department shall review  
18 requests for conformance with the requesting entity's information technology plan  
19 and compliance with statewide policies and standards. If the request is not in  
20 conformance or compliance, the department may disapprove the request or require  
21 justification for the departure from the plan or statewide policy or standard.

22 6. Shall provide information technology, including assistance and advisory service, to  
23 the executive, legislative, and judicial branches. If the department is unable to  
24 fulfill a request for service from the legislative or judicial branch, the information  
25 technology may be procured by the legislative or judicial branch within the limits of  
26 legislative appropriations.

27 7. Shall request and review information, including project startup information  
28 summarizing the project description, project objectives, business need or problem,  
29 cost-benefit analysis, and project risks and a project closeout information  
30 summarizing the project objectives achieved, project budget and schedule  
31 variances, and lessons learned, regarding any major information technology

project of an executive branch agency, ~~the state board of higher education, or any~~  
~~institution under the control of the state board of higher education as provided in~~  
~~section 54-35-15.2.~~ The department shall present the information to the  
information technology committee on request of the committee.

8. May request and review information regarding any information technology project  
of an executive branch agency with a total cost of between one hundred thousand  
and two hundred fifty thousand dollars as determined necessary by the  
department. The department shall present the information to the information  
technology committee on request of the committee.

9. Shall study emerging technology and evaluate its impact on the state's system of  
information technology.

10. Shall develop guidelines for reports to be provided by each agency of the  
executive, legislative, and judicial branches, excluding the institutions under the  
control of the board of higher education, on information technology in those  
entities.

11. Shall collaborate with the state board of higher education on guidelines for reports  
to be provided by institutions under control of the state board of higher education  
on information technology in those entities.

12. ~~Shall review the information technology management of executive branch agencies~~  
~~or institutions.~~

~~13.~~ Shall perform all other duties necessary to carry out this chapter.

~~14.~~ 13. May provide wide area network services to a state agency, city, county, school  
district, or other political subdivision of this state. The information technology  
department may not provide wide area network service to any private, charitable,  
or nonprofit entity except the information technology department may continue to  
provide the wide area network service the department provided to the private,  
charitable, and nonprofit entities receiving services from the department on  
January 1, 2003. ~~The department shall file with the state auditor before~~  
~~September 1, 2003, a description of the wide area network service the department~~  
~~provided to each private, charitable, and nonprofit entity receiving services from the~~  
~~department on January 1, 2003.~~

1     ~~45.~~ 14.     Shall assure proper measures for security, firewalls, and internet protocol  
2                   addressing at the state's interface with other facilities.

3     ~~46.~~ 15.     Notwithstanding subsection ~~44~~ 13, may provide wide area network services for a  
4                   period not to exceed four years to an occupant of a technology park associated  
5                   with an institution of higher education or to a business located in a business  
6                   incubator associated with an institution of higher education.

7             **SECTION 2. AMENDMENT.** Section 54-59-08 of the North Dakota Century Code is  
8     amended and reenacted as follows:

9             **54-59-08. Required use of wide area network services.** Each state agency and  
10    institution that desires access to wide area network services and each county, city, and school  
11    district that desires access to wide area network services to transmit voice, data, or video  
12    outside that county, city, or school district shall obtain those services from the department. The  
13    chief information officer may exempt from the application of this section a county, city, or school  
14    district that demonstrates its current wide area network services are more cost-effective for or  
15    more appropriate for the specific needs of that county, city, or school district than wide area  
16    network services available from the department. ~~The chief information officer shall exempt from~~  
17    ~~the application of this section a county, city, or school district that is under contract to receive~~  
18    ~~wide area network services from an entity other than the department, for the term of that~~  
19    ~~contract, but that political subdivision may not extend or renew that contract beyond July 31,~~  
20    ~~2001.~~

21            **SECTION 3. AMENDMENT.** Section 54-59-11 of the North Dakota Century Code is  
22    amended and reenacted as follows:

23            **54-59-11. Information technology plans.** Each executive branch state agency or  
24    institution, excluding the institutions under the control of the board of higher education, unless  
25    the chief information officer grants an exemption, shall ~~prepare an~~ participate in the information  
26    technology plan, ~~subject to acceptance by the department~~ planning process based on  
27    guidelines developed by the department. The plan must be submitted to the department by  
28    ~~July~~ August fifteenth of each even-numbered year unless the chief information officer grants an  
29    extension. ~~The plan must be prepared based on guidelines developed by the department; must~~  
30    ~~provide the information technology goals, objectives, and activities of the entity for the current~~  
31    ~~biennium and the next two bienniums; and must include an asset management plan relating to~~

1 ~~the inventory of information technology assets owned, leased, or employed by the entity. Each~~  
2 ~~entity required to file a plan shall provide interim updates to its plan if major information~~  
3 ~~technology changes occur which affect its plan. The department shall review each entity's plan~~  
4 ~~for compliance with statewide information technology policies and standards and may require~~  
5 ~~an entity to change its plan to comply with statewide policies or standards or to resolve~~  
6 ~~conflicting directions among plans. Agencies of the judicial and legislative branches shall file~~  
7 ~~their information technology plans with the department by July August fifteenth of each~~  
8 ~~even-numbered year. Each entity required to file a plan shall prepare its budget request for the~~  
9 ~~next biennium based on its information technology plan. The agency's budget request and the~~  
10 ~~governor's budget recommendation must include supporting information describing in detail~~  
11 ~~how the information technology plan relates to the budget request and recommendation. Any~~  
12 ~~budget adjustment by the budget office must include the corresponding change to the plan.~~  
13 Based on the plans, the department shall prepare a statewide information technology plan and  
14 distribute copies of that plan to members of the legislative assembly as requested by the  
15 legislative council or its designee. The statewide information technology plan must be  
16 developed with emphasis on long-term strategic goals, objectives, and accomplishments. The  
17 statewide information technology plan must contain:

- 18 1. ~~A list of major projects started, ongoing, and completed during the biennium,~~  
19 ~~including related budgeted and actual costs and the estimated implementation date~~  
20 ~~for each project as well as the actual implementation date for completed projects.~~
- 21 2. ~~Information regarding evaluations of cost-benefit analyses for completed projects.~~
- 22 3. ~~Information regarding the information technology plans, including the department's~~  
23 ~~plan review process, the number of plans reviewed, and the number of plans~~  
24 ~~accepted.~~
- 25 4. ~~A description of the benefits to the state resulting from its investment in information~~  
26 ~~technology.~~
