- 1009 § 6 Study the cooperative agreement between the Agriculture Commissioner and the United States Department of Agriculture Wildlife Services Program, including a review of program funding sources and a review of wildlife damage control programs in other states, including South Dakota
- 1459 § 4 Study the weed control programs of the Army Corps of Engineers on federal land under its control, including whether the Army Corps of Engineers is in compliance with federal and any applicable state weed control laws, whether the Army Corps of Engineers sufficiently budgets funds to address weed control on Army Corps of Engineers' land, and whether Congress provides proper funding for weed control on Army Corps of Engineers' land
- 3045 Study severed and abandoned mineral rights and methods to reduce the discount for oil produced in North Dakota
- 4027 Study the leasing of state lands
- Receive report from the Parks and Recreation Department by September 1, 2010, on the findings and recommendations of the study by the Parks and Recreation Department, State Historical Society, Game and Fish Department, and the Tourism Division of the Department of Commerce on linking and improving a series of public sites along the Sibley and Sully historic trails for historical education, heritage tourism, and access for public hunting (2009 S.L., ch. 523, § 1)
