- 1 A BILL for an Act to create and enact a new section to chapter 39-01 of the North Dakota
- 2 Century Code, relating to smoking in vehicles; to amend and reenact subsection 1 of section
- 3 39-06.1-06 and section 39-06.1-08 of the North Dakota Century Code, relating to statutory fees
- 4 for nonmoving violations; and to provide a penalty.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 6 **SECTION 1.** A new section to chapter 39-01 of the North Dakota Century Code is created 7 and enacted as follows:
- 8 Smoking in motor vehicle.
- 9 <u>1. It is unlawful for the operator or any passenger in a motor vehicle to ignite or smoke a</u>
- 10 <u>cigarette, pipe, cigar, or other combustible material if an individual under thirteen years</u>
- of age is present in the vehicle, regardless of whether a window of the motor vehicle is
- down or whether the vehicle is parked or on private property.
- 2. Probable cause for a violation of this section must be based solely upon a law
- enforcement officer's clear and unobstructed view of an individual smoking as
- 15 <u>prohibited by this section.</u>
- 16 <u>3. Operators' license points may not be assessed against an individual for a violation of</u>
- this section.
- 18 **SECTION 2. AMENDMENT.** Subsection 1 of section 39-06.1-06 of the North Dakota
- 19 Century Code is amended and reenacted as follows:
- 1. For a nonmoving violation as defined in section 39-06.1-08, a fee of any amount not to
- 21 exceed twenty dollars, except for a violation of section 1 of this Act, a fee of fifty
- 22 <u>dollars.</u>
- 23 **SECTION 3. AMENDMENT.** Section 39-06.1-08 of the North Dakota Century Code is
- 24 amended and reenacted as follows:

1 39-06.1-08. Nonmoving violation defined.

- 2 For the purposes of section 39-06.1-06, a "nonmoving violation" means:
- A violation of section 1 of this Act, section 39-04-11, subsection 6 of section 39-06-17,
 and section 39-06-44, 39-06-45, 39-10-47, 39-10-49, 39-10-50, 39-10-51, 39-10-54.1,
 39-21-08, 39-21-10, 39-21-11, or 39-21-14, or a violation of any municipal ordinance
- 6 equivalent to the foregoing sections.
- A violation, discovered at a time when the vehicle is not actually being operated, of section 39-21-03, 39-21-05, 39-21-13, 39-21-19, 39-21-32, 39-21-37, 39-21-39, or 39-21-44.2, or a violation of any municipal ordinance equivalent to the foregoing sections.
