- 1 A BILL for an Act to create and enact chapter 61-24.8 of the North Dakota Century Code,
- 2 relating to creation of special assessment districts for water supply or irrigation districts irrigation
- 3 works by the Garrison Diversion Conservancy District; to amend and reenact section

4 <u>54-35-02.7 of the North Dakota Century Code, relating to membership and duties of the</u>

5 water-related topics overview committee; to provide for reports to the state water commission;

6 and to provide an expiration date.

7 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

8 SECTION 1. AMENDMENT. Section 54-35-02.7 of the North Dakota Century Code is
9 amended and reenacted as follows:

54-35-02.7. (Effective through November 30, 2013) Water-related topics overview
 committee - Duties.

12 The legislative management, during each interim, shall appoint a water-related topics 13 overview committee in the same manner as the legislative management appoints other interim 14 committees. The committee must meet quarterly and is responsible for legislative overview of 15 water-related topics and related matters and for any necessary discussions with adjacent states 16 on water-related topics. During the 2011-12 interim, the committee shall review the state's 17 irrigation laws and rules and evaluate the process of the prioritization of water projects. The 18 committee consists of ninethirteen members and the legislative management shall designate 19 the chairman of the committee. The committee shall operate according to the statutes and 20 procedure governing the operation of other legislative management interim committees. 21 (Effective after November 30, 2013) Garrison diversion overview. The legislative 22 management is responsible for legislative overview of the Garrison diversion project and related 23 matters and for any necessary discussions with adjacent states on water-related topics.

- **SECTION 2.** Chapter 61-24.8 of the North Dakota Century Code is created and enacted as
- 2 follows:
- 3 61-24.8-01. Definitions. 4 As used in this chapter: 5 1. "Auditor" means the county auditor. 6 2. "Board" means the board of directors of the Garrison Diversion Conservancy District. 7 3. "Bond" means any revenue bond, refunding bond, improvement bond, or other 8 evidence of indebtedness of the district issued under this chapter. 9 "Direct benefit" means water is delivered to a tract of land. <u>4.</u> 10 5. "Director" means a member of the board of directors. 11 5.6. "District" means the Garrison Diversion Conservancy District. 12 6.7. "Federal agency" includes the United States, the president of the United States, or any 13 agency, instrumentality, or corporation of the United States which has been or may be 14 designated or created by or pursuant to any act or acts or joint resolutions of the 15 Congress of the United States or which may be owned or controlled, directly or 16 indirectly, by the United States. 17 7.8. "Holder of bonds" or "bondholder", or any similar term, means any person who is the 18 registered owner of any outstanding revenue bond, improvement bond, or refunding 19 bond. 20 8.9. "Law" means any statute of this state. 21 9.10. "Project" means any work, undertaking, enterprise, or any combination of two or more 22 projects, which the district is authorized to construct. The term includes all irrigation 23 improvements, betterments, extensions, and replacements of work, undertaking, or 24 enterprises, and all appurtenances, facilities, easements, lands, rights in land, water 25 rights, contract rights, approaches, dams, reservoirs, generating stations, trunk 26 connections, other water mains, filtration works, pumping stations, equipment, 27 franchises, and structures in connection with or incidental to any irrigation work, 28 undertaking, or enterprise the district is authorized to construct. 29 10.11. "Refinancing" means funding, refunding, paying, or discharging by means of refunding 30 bonds or the proceeds from the sale of refunding bonds, all or any part of any notes,

1		bonds, or other obligations issued to finance or to aid in financing the acquisition,
2	1	construction, or improvement of a project.
3	<u> 11.12.</u>	"Refunding bonds" means notes, bonds, certificates, or other obligations of the district
4		issued under this chapter, the proceeds of which are to be used to pay the principal of
5	1	or interest on any outstanding bonds or other obligations.
6	<u>12.13.</u>	"Revenues" means all fees, tolls, rates, rentals, and charges levied and collected by
7		the district in connection with, and all other income and receipts of whatever kind or
8	I	character derived by the district from, the operation of any project.
9	<u>13.14.</u>	"State engineer" has the same meaning as provided in chapter 61-03.
10	<u> 14.15.</u>	"Warrant" means an order drawn by the proper official of the district on its treasury, the
11		warrant to be so drawn that when signed by the district treasurer in an appropriate
12		place it becomes a check on the depository of the district, and a warrant upon the
13		treasury may not be delivered or mailed to the payee or the payee's agent or
14		representative until the warrant has been signed by the district treasurer and entered
15		on the district's books as a check drawn on a bank depository.

- 3 the board. Unless otherwise provided in the resolution, the resolution under this section takes

4 effect immediately and need not be laid over, published, or posted.

- 5 61-24.8-04. Construction.
- 6 Powers under this chapter are in addition and supplemental to and not in substitution for,
- 7 and the limitations imposed by this chapter do not affect the powers conferred by, any other law.
- 8 Bonds may be issued under this chapter without regard to any other laws of this state, except
- 9 as provided in section 61-24-29. The project may be acquired, purchased, constructed,
- 10 reconstructed, improved, bettered, and extended, and bonds may be issued under this chapter
- 11 for those purposes, notwithstanding that any other law may provide for the acquisition,
- 12 purchase, construction, reconstruction, improvement, betterment, and extension of a like project
- 13 or for the issuance of bonds for like purposes, and without regard to the requirements,
- 14 restrictions, debt, or other limitations or other provisions contained in any other law, including
- 15 any requirement for any restriction or limitation on the incurring of indebtedness or the issuance
- 16 of bonds. If this chapter is inconsistent with any other law of this state, the provisions of this
- 17 <u>chapter are controlling with reference to the issuance of bonds.</u>
- 18 <u>61-24.8-05. Power of district to defray expense of improvements by special</u>

19 assessments.

- 20 Upon complying with this chapter, the district may defray the expense of any or all of the
- 21 improvements by special assessments, including the construction of all or part of an irrigation
- 22 water supply system or an irrigation system, or both, works or any improvement, extension, or
- 23 replacement of such systems works, including the construction and erection of wells, intakes,
- 24 pumping stations, settling basins, filtration plants, standpipes, water towers, canals, ditches,
- 25 aqueducts, reservoirs, water mains, and outlets, and all other appurtenances, contrivances, and
- 26 <u>structures used or useful for a complete watercentral supply systemworks. In planning an</u>
- 27 improvement project, the board may include in the plans any and all items of work and
- 28 materials, which in its judgment are necessary or reasonably incidental to the completion of an
- 29 improvement project of that type.

1	61-24.8-06. Condemnation of land and rights of way for special improvements -
2	Taking of possession - Trial - Appeal - Vacation of judgment.
3	When property required to make any improvement authorized by this chapter is to be taken
4	by condemnation proceedings, the court, upon request by resolution of the board of the district
5	making the improvement, shall call a special term of court for the trial of the proceedings and
6	may summon a jury for the trial. The proceedings must be instituted and prosecuted in
7	accordance with chapter 32-15, except that when the interest sought to be acquired is a right of
8	way for the laying of any main, pipe, ditch, canal, aqueduct, or flume for conducting water,
9	whether within or without the district, the district may make an offer to purchase the right of way
10	and may deposit the amount of the offer with the clerk of the district court of the county in which
11	the right of way is located, and may then take possession of the right of way. The offer must be
12	made by resolution of the board of the district, and a copy of the resolution must be attached to
13	the complaint filed with the clerk of court in accordance with section 32-15-18. The clerk shall
14	immediately notify the owners of the land on which the right of way is located of the deposit by
15	causing a notice to be appended to the summons when served and published in the
16	proceedings as provided in the North Dakota Rules of Civil Procedure stating the amount
17	deposited or agreed in the resolution to be deposited. The owner may then appeal to the court
18	by filing an answer to the complaint in the manner provided in the North Dakota Rules of Civil
19	Procedure and may have a jury trial, unless a jury is waived, to determine the damages.
20	However, upon due proof of the service of the notice and summons and upon deposit of the
21	aggregate sum agreed in the resolution, the court without further notice may make and enter an
22	order as authorized by section 16 of article I of the Constitution of North Dakota. If under laws of
23	the United States proceedings for the acquisition of any right of way are required to be instituted
24	in or removed to a federal court, the proceedings may be taken in that court in the same
25	manner and with the same effect as provided in this section and the clerk of the district court of
26	the county in which the right of way is located shall perform any and all of the duties set forth in
27	this section if the clerk is directed to do so by the federal court. The proceedings must be
28	determined as speedily as practicable. An appeal from a judgment in the condemnation
29	proceedings must be taken within sixty days after the entry of the judgment and appeal must be
30	given preference by the supreme court over all other civil cases except election contests. No
31	final judgment in the condemnation proceedings awarding damages to property used by the

1	district for irrigation or other purposes may be vacated or set aside if the district pays to the
2	defendant, or into court for the defendant, the amount awarded in cash. The district may levy
3	special assessments within the district to pay all or part of the judgment. To provide funds for
4	the payment of the judgment or for the deposit of the amount offered for purchase of a right of
5	way, the district may issue bonds on the fund of the improvement district as provided in
6	section 61-24.8-09 in anticipation of the levy and collection of special assessments or revenues
7	to be appropriated to the fund in accordance with this chapter. The bonds may be issued upon
8	or after the commencement of the condemnation proceedings. Upon the failure of the district to
9	make payment in accordance with this section, the judgment in the condemnation proceedings
10	may be vacated.
11	61-24.8-07. Improvement districts to be created.
12	For an improvement project under section 61-24.8-05 and defraying the cost of the project
13	by special assessments, the district may create water districts and irrigation improvement
14	districts, and may extend any such district when necessary. The appropriate special
15	improvement district must be created by resolution. The special improvement district must be
16	directly designated by a name appropriate to the type of improvement for which it is created and
17	by a number distinguishing it from other improvement districts. Nothing in this chapter prevents
18	the district from making and financing any improvement under any alternate procedure in this
19	title. For examinations or surveys, the board or its employees, after written notice to each
20	landowner, may enter upon any land on which the proposed project is located or any other
21	lands necessary to gain access.
22	61-24.8-08. Size and form of improvement districts - Regulations governing.
23	Any improvement district created by the district may embrace two or more separate
24	property areas. Each improvement district must be of such size and form as to include all
25	properties, which in the judgment of the board, after consultation with the engineer planning the
26	improvement, will be benefited by the construction of the improvement project which is
27	proposed to be made in or for the district, or by any portion of the project. A single district may
28	be created for an improvement of the type specified in section 61-24.8-07, notwithstanding any
29	lack of uniformity among the types, items, or quantities of work and materials to be used at
30	particular locations throughout the improvement district. The jurisdiction of the district to make,
31	finance, and assess the cost of any improvement project may not be impaired by any lack of

1	commonness, unity, or singleness of the location, purpose, or character of the improvement, or
2	by the fact that any one or more of the properties included in the improvement district is
3	subsequently determined not to be benefited by the improvement, or by a particular portion of
4	the improvement project, and is not assessed for that purpose. The board may omit from a
5	water or irrigation an improvement district property within the improvement district limits which
6	are benefited by the improvement but do not abut upon a water or irrigation main, without
7	prejudice to the right and power of the district subsequently to assess such property to the
8	extent and the manner permitted by law. The board may by resolution enlarge an improvement
9	district in which an improvement is proposed-or, under construction, or in existence upon receipt
10	of a petition signed by the owners of three-fourthsall of the area to be added to the district.
11	61-24.8-09. Engineer's report required - Contents.
12	After a special improvement district has been created, the board, if the board determines it
13	necessary to make any of the improvement set out in section 61-24.8-05 in the manner
14	provided in this chapter, shall direct the engineer for the district, or some other competent
15	engineer, to prepare a report as to the general nature, purpose, and feasibility of the proposed
16	improvement. The engineer shall prepare profiles, plans, and specifications of the proposed
17	project and estimates of the total cost. The estimate of costs prepared by the engineer must
18	include acquisition of right of way and other costs specified in section 61-24.8-19 and must be
19	in sufficient detail to allow the board to determine the probable share of the total costs that will
20	be assessed against each of the affected landowners in the proposed assessment district.
21	61-24.8-10. Approval of plans, specifications, and estimates.
22	After receiving the engineer's report required by section 61-24.8-09, the board may direct
23	the engineer to prepare detailed plans and specifications for construction of the improvement.
24	The plans and specifications must be approved by a resolution of the board.
25	61-24.8-11. District engineer to retain copy of plans, specifications, and estimates -
26	Sale of copies.
27	The engineer acting for the district shall retain a copy of the plans, specifications, and
28	estimates that have been prepared for any improvement. The engineer shall furnish copies at
29	the request of any person at a reasonable cost.

1	61-24.8-12. Plans, specifications, and estimates filed in office of district.
2	The plans, specifications, and estimates prepared as directed under section 61-24.8-10 are
3	the property of the district, must be filed in the district office, and must remain on file subject to
4	inspection by any interested person.
5	<u>61-24.8-13. Hearing - Notice - Contents.</u>
6	Upon the filing of the engineer's report provided for in section 61-24.8-09, and after
7	satisfying the requirements of section 61-24.8-10, the district board shall fix a date and place for
8	public hearing on the proposed project. The place of hearing must be in the vicinity of the
9	proposed project and must be convenient and accessible for the majority of the landowners
10	subject to assessment for the project or whose property is subject to condemnation for the
11	proposed project. The board may appoint a hearing officer or a committee of the board to
12	conduct the hearing. The board shall cause a complete list of the benefits and assessments to
13	be made, setting forth each political subdivision assessed in its corporate capacity as well as
14	each lot, piece, or parcel of land assessed, the amount each is benefited by the improvement,
15	and the amount assessed against each. At least tenfourteen days before the hearing, the board
16	shall file with the county auditor of each county in which the project is or will be located the list
17	showing the percentage assessment and approximate assessment in dollars against each
18	parcel of land benefited by the proposed project. Notices of the hearing must contain the time
19	and place where the board will conduct the hearing. The notice of hearing must specify when
20	and where votes concerning the proposed project may be filed and contain an assessment list
21	showing the percentage assessment and approximate assessment in dollars against each
22	parcel of land benefited by the proposed project. The board shall cause the notice of hearing to
23	be published once a week for two consecutive weeks in newspapers of general circulation in
24	the area in which the affected landowners reside and in the official county newspaper of each
25	county in which the benefited lands are located. The date set for the hearing may not be fewer
26	than fourteen days after the first publication of the notice. A record of the hearing must be made
27	by the board, including a list of affected landowners present in person or by agent, and the
28	record must be preserved in the minutes of the meeting. Affected landowners and the governing
29	body of any county, township, or city to be assessed must be informed at the hearing of the
30	probable total cost of the project and their individual share of the cost and the portion of their
31	property, if any, to be condemned for the project.

1 61-24.8-14. Voting on proposed projects. 2 At the hearing, the affected landowners and any county, township, or city to be assessed 3 must be informed when and where votes concerning the proposed project may be filed. Affected 4 landowners-and the governing body of any county, township, or city to be assessed have thirty 5 days after the date of the hearing to file their votes with the secretary of the district. Once the 6 deadline for filing votes has been reached, no more votes may be filed and no person may 7 withdraw a vote. Any withdrawal of a vote concerning the proposed project before that time 8 must be in writing. When the votes have been filed and the deadline for filing votes has passed. 9 the board shall immediately determine whether the project is approved. If the board finds that 10 fifty one hundred percent or more of the total votes filed are against for the proposed project, 11 then the vote constitutes a bar against proceeding further with an affirmation of the project. If the 12 board finds that the number of votes filed against the proposed project is less than fifty percent 13 of the votes filed, and the board shall issue an order establishing the proposed project and may 14 proceed, after complying with the requirements of sections 61-24.8-17 and 61-24.8-18, to 15 contract or provide for the construction or maintenance of the project in substantially the 16 manner and according to the forms and procedure provided in sections 61-24.8-43 through-17 61-24.8-58 section 61-24.8-41. The board may enter any agreement with any federal or state 18 agency under the terms of which the contract for the project is to be let by the federal agency. 19 the state agency, or a combination thereof. In projects where there is an agreement that a party 20 other than the board will let the contract, the board may dispense with all of the requirements of 21 sections 61-24.8-43 through 61-24.8-58 section 61-24.8-41. Upon making an order establishing 22 or denying establishment of a project, the board shall publish notice of the order in a newspaper 23 of general circulation in the area in which the affected landowners reside and in the official 24 county newspaper of each county in which the benefited lands are located. Any right of appeal 25 begins to run on the date of publication of the notice. 26 61-24.8-15. Voting right or powers of landowners. 27 In order that there may be a fair relationship between the amount of liability for 28 assessments and the power of objecting to the establishment of a proposed project, the voting 29 rights of affected landowners on the question of establishing the project are as provided in this 30 section. The landowner of land affected by the project has one vote for each dollar of 31 assessment to which the land is subject or one vote for each dollar of the assessed valuation of

1	land condemned, or used for construction, for the project, as determined in accordance with title
2	57. The governing body of any political subdivision to be assessed has one vote for each dollar
3	of assessment against such political subdivision. There may be only one vote for each dollar of
4	assessment, regardless of the number of owners of a tract of land. If more than one owner of a
5	tract of land exists, the votes must be prorated among them in accordance with each owner's
6	property interest. A written power of attorney authorizes an agent to protest a project on behalf
7	of any affected landowner or landowners.
8	61-24.8-16. Assessment of cost of project.
9	When the district board proposes to make any special assessment under this chapter, the
10	board or its agent, before the hearing required under section 61-24.8-13, shall inspect any and
11	all lots and parcels of land that may be subject to assessment and shall determine from the
12	inspection the particular lots and parcels of lands which, in the opinion of the board, will be
13	especially directly benefited by the construction of the work for which the assessment is made
14	and shall assess the proportion of the total cost of acquiring right of way and constructing and
15	maintaining such improvement in accordance with direct benefits received but not exceeding
16	such benefits against:
17	<u>1. Any political subdivision, in its corporate capacity, which may be directly or indirectly</u>
18	benefited by the improvement; and
19	2. <u>Any any lot, piece, or parcel of land that is directly benefited by the improvement.</u>
20	In determining benefits, the board shall consider, among other factors, property values, degree
21	of improvement of properties, and productivity. Property belonging to the United States is
22	exempt from assessment unless the United States has provided for the payment of any
23	assessment that may be levied against its property for benefits received. Benefited property
24	belonging to the state or political subdivision is not exempt from assessment and the state and
25	political subdivisions that own assessed property shall provide for the payment of such
26	assessments, including installments and interest, by the levy of taxes according to law. Any
27	political subdivision assessed in its corporate capacity for benefits received shall provide for the
28	payment of those assessments, installments, and interest from its general fund or by levy of a
29	general property tax against all the taxable property in the political subdivision in accordance
30	with law. No tax limitation provided by any statute of this state applies to tax levies made by any
31	political subdivision for paying any special assessments made under this chapter. There must

- 1 be attached to the list of assessments a certificate signed by the chairman and certified by the
- 2 secretary that it is a true and correct assessment of the benefit described to the best of their
- 3 judgment and stating the several items of expense included in the assessment.

4 <u>61-24.8-17. Assessment list to be published - Notice of hearing - Alteration of</u>

5 assessments - Confirmation of assessment list - Filing.

- 6 <u>After entering an order establishing the project, the district board shall cause the</u>
- 7 assessment list to be published once each week for two successive weeks in the newspapers
- 8 of general circulation in the district and in the official county newspaper of each county in which
- 9 the benefited lands are located. The publication must include a notice of the time and place the
- 10 board will meet to hear objections to any assessment by any interested party or an agent or
- 11 attorney for that party. The date set for the hearing must be not less than fourteen days after the
- 12 first publication of the notice. At the hearing, the board may make such alterations in the
- 13 assessments as in its opinion may be just and necessary to correct any error in the assessment
- 14 but must make the aggregate of all assessments equal to the total amount required to pay the
- 15 <u>entire cost of the work for which the assessments are made or the part of the cost to be paid by</u>
- 16 special assessment. An assessment may not exceed the benefit as determined by the board to
- 17 the parcel of land or political subdivision assessed. The board then shall confirm the
- 18 assessment list and the secretary shall attach to the list a certificate that it is correct as
- 19 <u>confirmed by the board. The secretary shall file the list must be filed in the office of the district</u>
- 20 secretary.
- 21

61-24.8-18. Appeal to state engineer.

- 22 Within ten days after the hearing under section 61-24.8-17, affected landowners-and any-
- 23 political subdivision subject to assessment, having not less than twenty-five percent of the

24 possible votes as determined under section 61-24.8-15, who believe that the assessment has

- 25 not been fairly or equitably made, or that the project is not properly located or designed, may
- 26 petition the state engineer to review the assessments and examine the location and design of
- 27 the proposed project. Upon receipt of a petition, the state engineer shall examine the lands
- 28 assessed and the location and design of the proposed project. If it appears to the state engineer
- 29 that the assessments have not been made equitably, the state engineer may proceed to correct
- 30 the assessments. The state engineer's correction and adjustment of assessments is final. If it
- 31 appears to the state engineer that the project has been improperly located or designed, the

1	state engineer may order a relocation and redesign, which must be followed in the construction
2	of the proposed project. Upon filing a bond for two hundred fifty dollars with the board for the
3	payment of the costs of the state engineer in the matter, anyAny landowner or political
4	subdivision claiming to receive no direct benefit from the project may appeal to the state
5	engineer the question of whether there is any direct benefit. The appeal must be filed with the

9	day work basis or a contract may be let without being advertised. If the costs of the construction
10	or maintenance exceed the amount provided for construction of a public improvement under
11	section 48-01.2-02, the board must let a contract in accordance with chapter 48-01.2.
12	SECTION 3. REPORT TO STATE WATER COMMISSION. The Garrison Diversion
13	Conservancy District shall report periodically to the state water commission on the development
14	and status of irrigation projects constructed under this Act.
15	SECTION 4. EXPIRATION DATE. This Act is effective through July 31, 2013, and after that
16	date is ineffective.
