## **ENGROSSED HOUSE BILL NO. 1376**

- 1 A BILL for an Act to amend and reenact sections 43-49-07, 43-49-09, and 43-09-11 of the North
- 2 Dakota Century Code, relating to licensure of reflexologists.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 43-49-07 of the North Dakota Century Code is
- 5 amended and reenacted as follows:
- 6 43-49-07. Reciprocity Qualification for licensure by an applicant licensed in another
- 7 jurisdiction.
- 8 Notwithstanding the requirements in section 43-49-06 for the issuance of a license, the
- 9 board shall license an individual from who applies for licensure to work in this state if the
- 10 applicant is licensed as a reflexologist by another state who, applies for licensure, pays the
- 11 applicable fee, meets or exceeds the requirements for licensure set by the board, and who has
- 12 no imposed or pending disciplinary actions.
- 13 **SECTION 2. AMENDMENT.** Section 43-49-09 of the North Dakota Century Code is
- 14 amended and reenacted as follows:
- 15 **43-49-09. License Display Renewal Renewal fee.**
- 16 Each license must be conspicuously displayed at the place of practice. A license must be
- 17 recorded within thirty days after issuance in the office of the recorder, unless the board of
- 18 county commissioners designates a different official, in any county where the reflexologist
- 19 practices.
- A license must be renewed before June first of each year. The secretary-treasurer of the
- 21 board shall mail notice of renewal to each licensed reflexologist's address as shown in the
- 22 records of the board at least thirty days before the expiration of the license. The notice must
- 23 include any requests for information necessary for renewal. The licensed reflexologist may
- renew a license by sending a renewal fee of twenty-five dollars, or anthe amount set by the

- 1 board, not to exceed one hundred dollars, to the secretary-treasurer of the board, and
- 2 submitting proof that the reflexologist has attended a seminar on reflexology at least once
- 3 during the preceding three years. A license that is not renewed by June thirtieth lapses.
- 4 **SECTION 3. AMENDMENT.** Section 43-49-11 of the North Dakota Century Code is
- 5 amended and reenacted as follows:
- 6 **43-49-11. Prohibited practices.**
- 7 A reflexologist may not use lotions, creams, or mechanical devices in the application of
- 8 reflexology. A reflexologist may not diagnose or treat for specific diseases, practice spinal or
- 9 other joint manipulations, or prescribe or adjust prescription medication, and prescribe or
- 10 administer vitamins.
