

**HOUSE BILL NO. 1095**

Introduced by

(At the request of the Department of Human Services)

1 A BILL for an Act to amend and reenact sections 50-11-00.1 and 50-11-03.2 of the North Dakota  
2 Century Code, relating to the approval process of group foster care facilities.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Section 50-11-00.1 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **50-11-00.1. Definitions.**

7 As used in this chapter:

- 8 1. "Approval" means the approval by the department of a home of a Native American  
9 family located on a recognized Indian reservation in North Dakota or of a facility  
10 owned by the tribe or a tribal member and located on a recognized Indian reservation  
11 in North Dakota, not subject to the jurisdiction of the state of North Dakota for licensing  
12 purposes, to allow the home or facility to receive title IV-E funding.
- 13 2. "Authorized agent" means the county social service board, unless another entity is  
14 designated by the department.
- 15 ~~2-3.~~ "Department" means the department of human services.
- 16 ~~3-4.~~ "Facility" means a family foster home for adults, family foster home for children, group  
17 home, or residential child care facility for children.
- 18 ~~4-5.~~ "Family foster home for adults" means an occupied private residence in which foster  
19 care for adults is regularly provided by the owner or lessee thereof, to four or fewer  
20 adults who are not related by blood or marriage to the owner or lessee, for hire or  
21 compensation.
- 22 ~~5-6.~~ "Family foster home for children" means an occupied private residence in which foster  
23 care for children is regularly provided by the owner or lessee thereof to no more than  
24 four children, unless all the children in foster care are related to each other by blood or

1 marriage or unless the department approves otherwise for the placement of siblings, in  
2 which case the limitation in this subsection does not apply.

3 ~~6-7.~~ "Foster care for adults" means the provision of food, shelter, security and safety,  
4 guidance, and comfort on a twenty-four-hour per day basis, in the home of a caregiver,  
5 to a person age eighteen or older, who is unable, neglects, or refuses to provide for  
6 the person's own care.

7 ~~7-8.~~ "Foster care for children" means the provision of substitute parental child care for  
8 those children who are in need of care for which the child's parent, guardian, or  
9 custodian is unable, neglects, or refuses to provide, and includes the provision of food,  
10 shelter, security and safety, guidance, and comfort on a twenty-four-hour basis, to one  
11 or more children under twenty-one years of age to safeguard the child's growth and  
12 development and to minimize and counteract hazards to the child's emotional health  
13 inherent in the separation from the child's family. Foster care may be provided in a  
14 family foster home, group home, or residential child care facility.

15 ~~8-9.~~ "Group home" means a residence in which foster care is regularly provided for more  
16 than four, but less than ten, unrelated children.

17 ~~9-10.~~ "Residential child care facility" means a facility other than an occupied private  
18 residence providing foster care to more than eight unrelated children, except as may  
19 be otherwise provided by rule or regulation.

20 **SECTION 2. AMENDMENT.** Section 50-11-03.2 of the North Dakota Century Code is  
21 amended and reenacted as follows:

22 **50-11-03.2. Use of public funds.**

23 Public funds for the purchase of foster care for children or adults may be used only in  
24 facilities licensed or approved by the department. No person acting on behalf of any state,  
25 county, or local governmental entity may arrange for or promote care provided in a facility that  
26 does not have a license or approval issued by the department. This section does not apply to  
27 any home or institution under the management and control of the state.
