4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the game and fish fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the game and fish department for the purpose of defraying the expenses of that agency, for the biennium beginning July 1, 2011, and ending June 30, 2013, as follows:

1 SECTION 2. APPROPRIATION - 2009-11 BIENNIUM WILDLIFE SERVICES -2 AGRICULTURE COMMISSIONER - LEGISLATIVE INTENT. There is appropriated out of any 3 moneys in the game and fish fund in the state treasury, not otherwise appropriated, the sum of 4 \$200,000, or so much of the sum as may be necessary, to the game and fish department for the 5 purpose of providing funds to the agriculture commissioner for the payment of wildlife services, 6 for the period beginning with the effective date of this Act and ending June 30, 2011. It is the 7 intent of the sixty-second legislative assembly that the funding provided in this section is from 8 the estimated savings to the game and fish department resulting from the reduction in property 9 tax liability resulting from provisions of Senate Bill No. 2199 approved by the sixty-first 10 legislative assembly. 11 SECTION 3. GRANTS, GIFTS, AND DONATIONS LINE. The grants, gifts, and donations 12 line item in section 1 of this Act includes up to \$400,000 received by the game and fish 13 department for surface damage, easements, or reclamation on department-owned or 14 department-managed properties as a result of mineral exploration and extraction activities. 15 SECTION 4. MISSOURI RIVER ENFORCEMENT. The Missouri River enforcement line 16 item in section 1 of this Act includes the sum of \$200,000 for salaries and operating expenses of 17 department employees coordinating or performing Missouri River law enforcement activities and 18 for grants to local law enforcement agencies performing Missouri River law enforcement 19 activities. The department may not use any of the funds for the purchase of equipment with a 20 cost of \$3,000 or more. 21 SECTION 5. LEGISLATIVE MANAGEMENT STUDY - WILDLIFE SERVICES. During the 22 2011-12 interim, the legislative management shall consider studying the cooperative agreement 23 between the agriculture commissioner and the United States department of agriculture wildlife 24 services program. The study, if conducted, must include a review of current program funding 25 sources and a review of wildlife damage control programs in other states. The legislative 26 management shall report its findings and recommendations, together with any legislation 27 required to implement the recommendations, to the sixty-third legislative assembly. 28 **SECTION 6. EMERGENCY.** Funding of \$400,000 included in the grants line item in 29 section 1 of this Act for a grant to the parks and recreation department for costs associated with 30 the project to raise the elevation of the Grahams Island state park access road, funding of 31 \$850,000 included in the land habitat and deer line item in section 1 of this Act relating to

- 1 hunting access and deer depredation, and section 2 of this Act are declared to be an
- 2 emergency measure.
