## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. A new section to chapter 10-04 of the North Dakota Century Code is created
   and enacted as follows:
- 9 Political subdivision, building authority, or other entity issuing bonds or evidences of
   10 indebtedness Reports Compilation of reported information.
- 11 Before the issuance of general obligation bonds, special improvement warrants or 12 bonds, or other evidences of indebtedness or before the issuance of bonds or other 13 evidences of indebtedness for acquisition, construction, renovation, or improvement of 14 a structure in connection with an agreement for use of that structure by a political 15 subdivision of this state, a political subdivision, building authority, or other entity 16 issuing those bonds or other evidences of indebtedness shall file with the 17 a report regarding that bond or other evidence of indebtedness 18 issue and, if applicable, any agreement for use of the structure. 25	indebtedness from that issue has not been retired as of August 1, 2013, and if the original issue		
26	of those bonds or evidences of indebtedness would have been subject to the reporting		
27	requirement of section 1 of this Act if the original issue had occurred after July 31, 2013.
