

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2187**

1 A BILL for an Act to amend and reenact sections 43-23.3-02, 43-23.3-03, and 43-23.3-04.1 of
2 the North Dakota Century Code, relating to the North Dakota real estate appraiser qualifications
3 and ethics board and appraiser permit approval standards; and to provide for application.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. AMENDMENT.** Section 43-23.3-02 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **43-23.3-02. North Dakota real estate appraiser qualifications and ethics board.**

8 1. The governor shall appoint the board. The board must consist of five members. One
9 member must represent the public; ~~one member must represent~~ be a representative of
10 the financial industry; and three members must be appraisers, at least one of which is
11 experienced in the appraisal of agricultural property. ~~The appraiser members first~~
12 ~~appointed to the board must be members in good standing of an organization~~
13 ~~belonging to the appraisal foundation or have the equivalent of five years of full-time~~
14 ~~experience as an appraiser in this state. Thereafter, each~~

15 a. Each appraiser member of the board must be either a licensed or certified
16 appraiser, but at least two of the appraiser members must be certified appraisers.

17 b. The governor shall appoint the financial industry representative from a list of
18 qualified individuals submitted by the North Dakota bankers associations, ~~the~~
19 ~~North Dakota credit union league, and the North Dakota league of savings~~
20 ~~institutions, the credit union association of the Dakotas, and the North Dakota~~
21 ~~farm credit system associations.~~ Each of these entities may submit two names of
22 candidates to the governor.

23 2. The term of each member is five years, ~~except that of the members first appointed,~~
24 ~~one shall serve for five years, one shall serve for four years, one shall serve for three~~

1 years, one shall serve for two years, and one shall serve for one year. A member may
2 not serve more than two consecutive five-year terms, after which at least two years
3 must pass before the governor may reappoint that former member to the board. The
4 governor shall appoint members so the terms of no more than two members expire
5 each year. A member of the board continues to hold office until the appointment and
6 qualification of a successor. The governor may remove a board member for cause.
7 The

8 3. Annually the members annually shall elect a chairman from among the members. At
9 least two of the members who are appraiser members must be present in order for a
10 quorum to exist. The members are entitled to receive compensation for each day
11 actually engaged in the service of the board and actual and necessary traveling
12 expenses at the rate allowed other state officials, paid from the fees collected by the
13 board.

14 **SECTION 2. AMENDMENT.** Section 43-23.3-03 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **43-23.3-03. Powers and duties of the board.**

- 17 1. The board, or ~~it~~the board's designated representative, shall:
- 18 a. Define apprentice appraiser, licensed appraiser, certified residential appraiser,
19 and certified general appraiser; determine the type of educational experience,
20 appraisal experience, and equivalent experience that meet the requirements of
21 this chapter; ~~and~~ establish application procedures; and establish standards for
22 approval and disapproval of applications for permits.
- 23 b. Establish examination specifications for each category of licensed and certified
24 appraiser and administer examinations.
- 25 c. Approve or disapprove applications for permits, issue pocket cards and permits
26 to practice, and maintain a registry of the names and addresses of individuals
27 holding permits.
- 28 d. Discipline permittees.
- 29 e. Hold meetings, hearings, and examinations in places and at times as ~~it~~the board
30 designates and maintain records of board activities.

- 1 f. Adopt rules, pursuant to chapter 28-32, necessary to implement this chapter or
2 carry out the requirements imposed by federal law.
- 3 g. Adopt rules that clearly and concisely establish the standards for approval and
4 disapproval of applications for permits. The rules must include a requirement that
5 an application disapproval clearly specify the basis for the disapproval.
- 6 h. Keep permittees informed of board activities, including providing notification of
7 board member terms and any upcoming board vacancy; internet posting of
8 meeting notices and minutes; and internet posting of proposed and final rule
9 changes.
- 10 2. The board, or ~~it~~the board's designated representative, may:
- 11 a. Promote research and conduct studies relative to real estate appraising and
12 sponsor educational activities.
- 13 b. Contract for services necessary to carry out this chapter.
- 14 c. Enter ~~into~~ reciprocity agreements with other states.
- 15 3. The board, or ~~it~~the board's authorized representative, may investigate and gather
16 evidence concerning alleged violations of the provisions of chapter 43-23.3 or the
17 rules of the board. Board investigative files are exempt records as defined in
18 subsection 5 of section 44-04-17.1, but a copy of the investigative file must be
19 provided to a licensee if a complaint is filed against the licensee by the board.

20 **SECTION 3. AMENDMENT.** Section 43-23.3-04.1 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **43-23.3-04.1. Issuance of permits to applicants licensed or certified by another state.**

23 The board ~~may~~shall issue a permit to an applicant who is licensed or certified in good
24 standing by another state if the other state's requirements to be licensed or certified are at least
25 substantially equivalent to the requirements imposed by this state, and if grounds for denial of
26 the application under section 43-23.3-18 do not exist. If an applicant was licensed or certified by
27 another state by reciprocity or a similar process, the requirements of the state in which the
28 applicant was originally licensed or certified must be at least substantially equivalent to the
29 requirements imposed by this state. Within sixty days of filing a completed application, the
30 board shall issue or deny the application and inform the applicant of the decision.

1 **SECTION 4. APPLICATION.** The change in the term limits for board members provided for
2 under section 1 of this Act applies to board member appointments and reappointments made
3 after July 31, 2011; therefore, the new term limit provisions do not disqualify any board member
4 serving on the effective date of this Act, but may prevent the governor from reappointing a
5 board member after the effective date of this Act.
