1 A BILL for an Act relating to the development of crop insurance proposals; and to provide an
2 appropriation.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1.**

5 **Crop insurance development board - Membership - Terms.**

- 6 1. The crop insurance development board consists of:
7 a. The governor or the governor's designee;
8 b. The agriculture commissioner or the commissioner's designee;
9 c. One individual appointed by the senate majority leader;
10 d. One individual appointed by the house majority leader;
11 e. One individual representing an agricultural organization in this state, appointed
12 by the governor;
13 f. One individual representing an agricultural organization in this state, appointed
14 by the agriculture commissioner; and
15 g. One individual involved in the crop insurance industry, appointed by the
16 agriculture commissioner.
17 2. The term of each appointed member is two years and begins on July 1, 2011.
18 3. An appointed member may serve consecutive terms.
19 4. If at any time a member ceases to possess any of the qualifications required by this
20 section or otherwise terminates the appointment, the member's office is deemed
21 vacant and must be filled in the same manner as the original appointment.

22 **SECTION 2.**

1 **Crop insurance development board - Chairman.**

2 1. Biennially, the crop insurance development board shall elect one member to serve as
3 the chairman. The chairman's term begins July 1, 2011. The chairman may serve
4 consecutive terms.

5 2. The chairman shall call all meetings of the board.

6 3. The board shall meet as often as necessary to fulfill its duties under section 4 of this
7 Act.

8 **SECTION 3.**

9 **Crop insurance development board - Compensation of board members.**

10 Each member of the crop insurance development board is entitled to receive compensation
11 in the amount established by the board but not exceeding one hundred thirty-five dollars per
12 day plus reimbursement for expenses as provided by law for state officers if the member is
13 attending meetings or performing duties directed by the board.

14 **SECTION 4.**

15 **Crop insurance development board - Duties.**

16 The crop insurance development board shall review and evaluate proposals submitted by
17 individuals and by public and nonpublic entities pertaining to the development and
18 implementation of crop insurance instruments. The board shall assess the feasibility and
19 desirability of the proposals. For those proposals that the board determines viable, the board
20 may award grants to assist with future actuarial and development costs. Grants may be
21 awarded for up to seventy-five percent of the first fifty thousand dollars and up to fifty percent
22 thereafter of the future actuarial and development costs. The board shall establish conditions
23 pertaining to the awarding of grants, including the repayment of some or all of the grants with
24 moneys received by the applicant from the federal crop insurance corporation for continued
25 development of the proposal. The board shall forward any moneys received as repayments
26 under this section to the state treasurer for deposit in the general fund.

27 **SECTION 5.**

28 **Confidential information.**

1 **Access to board records.**

2 Materials and data submitted to, or made or received by, the board, to the extent that the
3 board determines the materials or data consist of trade secrets or commercial, financial, or
4 proprietary information of individuals or entities applying to or contracting with the board or
5 receiving board services under this chapter are subject to section 44-04-18.4. The names or
6 identities of the independent technical reviewers on any project or program are confidential and
7 may not be disclosed by the board.

8 **SECTION 6. APPROPRIATION.** There is appropriated out of any moneys in the general
9 fund in the state treasury, not otherwise appropriated, the sum of \$1,000,000, or so much of the
10 sum as may be necessary, to the governor for the purpose of providing grants to public and
11 nonpublic entities pursuing the development and implementation of crop insurance instruments,
12 for the biennium beginning July 1, 2011, and ending June 30, 2013.
