1 A BILL for an Act to amend and reenact subsection 7 of section 26.1-04-03 of the North Dakota
2 Century Code, relating to prohibited practices in the insurance business.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. AMENDMENT.** Subsection 7 of section 26.1-04-03 of the North Dakota
5 Century Code is amended and reenacted as follows:

6 7. Unfair discrimination.

- 7 a. Making or permitting any unfair discrimination between individuals of the same
8 class and equal expectation of life in the rates charged for any contract of life
9 insurance or of life annuity or in the dividends or other benefits payable thereon,
10 or in any other of the terms and conditions of such contract.
- 11 b. Making or permitting any unfair discrimination, including consideration of an
12 individual's history or status as a subject of domestic abuse, between individuals
13 of the same class and of essentially the same hazard in the amount of premium,
14 policy fees, or rates charged for any policy or contract of accident or health
15 insurance or in the benefits payable thereunder, or in any of the terms or
16 conditions of such contract, or in any other manner whatsoever.
- 17 c. Refusing to insure, or refusing to continue to insure, or limiting the amount,
18 extent, or kind of life insurance, accident and sickness insurance, health services,
19 or health care protection insurance available to an individual, or charging an
20 individual a different rate for the same coverage solely because of blindness or
21 partial blindness. Refusal to insure includes denial by an insurer of disability
22 insurance coverage on the grounds that the policy defines "disability" as being
23 presumed in the event that the insured loses the insured's eyesight; however, an
24 insurer may exclude from coverage disabilities consisting solely of blindness or

1 partial blindness when such condition existed at the time the policy was issued.

2 With respect to all other conditions, including the underlying cause of the

3 blindness or partial blindness, persons who are blind or partially blind shall be

4 subject to the same standards of sound actuarial principles or actual or

5 reasonably anticipated experience as are sighted persons.

- 6 d. Making or permitting any unfair discrimination between individuals or risks of the
7 same class and of essentially the same hazard by refusing to insure, refusing to
8 renew, canceling, or limiting the amount of insurance coverage on a property or
9 casualty risk solely because of the geographic location of the risk, unless the
10 action is the result of the application of sound underwriting and actuarial
11 principles related to actual or reasonably anticipated loss experience.
