- 1 A BILL for an Act to create and enact a new section to chapter 57-38 and a new subdivision to
- 2 subsection 7 of section 57-38-30.3 of the North Dakota Century Code, relating to an income tax
- 3 credit for employment of individuals with disabilities; and to provide an effective date.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. A new section to chapter 57-38 of the North Dakota Century Code is created
6 and enacted as follows:

7 Tax credit for employment of individuals with disabilities. 8 1. As used in this section, "individual with disabilities" means: an individual with a 9 disability as defined under the Americans with Disabilities Act of 1990, and as-10 amended by the Americans with Disabilities Act Amendments Act of 2008-11 [Pub. L. 110-325, 122 Stat. 3553], and who is receiving services directly related to the 12 disabilities. 13 An individual who is receiving social security disability insurance or supplemental а. 14 security income; or 15 An individual: b 16 Who has severe physical or mental impairments that seriously limit the (1)17 individual's functional capacity, including mobility, communication, self-care, 18 self-direction, interpersonal skills, work tolerance, or work skills in terms of 19 an employment outcome; and 20 (2) Who has one or more physical or mental disabilities resulting from 21 amputation, arthritis, blindness, burn injury, cancer, cerebral palsy, cystic 22 fibrosis, deafness, head injury, heart disease, hemiplegia, hemophilia, 23 respiratory or pulmonary dysfunction, intellectual disability, mental illness, 24 multiple sclerosis, muscular dystrophy, musculoskeletal disorders,

1		neurological disorders (including stroke and epilepsy), paraplegia,
2		quadriplegia and other spinal cord conditions, sickle cell anemia, specific
3		learning disability, end-stage renal disease, or another disability or
4		combination of disabilities determined on the basis of an assessment for
5		determining eligibility and vocational rehabilitation needs to cause
6		comparable substantial functional limitations.
7	<u>2.</u>	A taxpayer who is an employer in this state is entitled to a tax credit as determined
8		under this section against state income tax liability under section 57-38-30 or
9		57-38-30.3 for the employment of an individual with disabilities. The amount of the
10		credit to which a taxpayer is entitled is fifty percent of up to five thousand dollars of
11		wages paid in the first year, thirty percent of up to five thousand dollars of wages paid
12	I	in the second year, and ten percent of up to five thousand dollars of wages paid in the
13		third year of employment of anto the newly hired individual with disabilities. The tax
14		credit under this section is available if the employment of the individual creates a net
15		increase in the number of individuals with disabilities employed by the taxpayer from
16		the number of individuals with disabilities employed by the taxpayer at the end of the
17		preceding taxable year.
18	<u>3.</u>	The taxpayer may claim the credit in the first tax year beginning after the individual
19		hired has completed the employee's first twelve consecutive months of employment by
20		the taxpayer and applies in subsequent tax years in which further net increases occur
21		above the level of such employment established when the credit was last taken.
22	<u>4.</u>	A partnership, subchapter S corporation, limited partnership, or limited liability
23		company, or any other entity treated as a passthrough entity for federal income tax
24		purposes must be considered to be the taxpayer for purposes of this section. The
25		amount of the credit determined at the entity level must be passed through to the
26		partners, shareholders, or members in proportion to their respective interests in the
27		passthrough entity.
28	8 SECTION 2. A new subdivision to subsection 7 of section 57-38-30.3 of the North Dakota	
29	29 Century Code is created and enacted as follows:
