SENATE CONCURRENT RESOLUTION NO. 4014

1	A concurrent resolution urging the Government of Turkey to grant the Ecumenical Patriarch
2	appropriate international recognition, ecclesiastical succession, and the right to train clergy of all
3	nationalities and to respect the property rights and human rights of the Ecumenical Patriarchate;
4	and for other purposes.
5	WHEREAS, the Ecumenical Patriarchate, located in Istanbul, Turkey, is the Sacred See
6	that presides in a spirit of cooperation over a communion of self-governing churches of the
7	Orthodox Christian world; and
8	WHEREAS, the See is led by Ecumenical Patriarch Bartholomew, who is the 269th in direct
9	succession to the Apostle Andrew and holds titular primacy as primus inter pares, meaning "first
0	among equals," in the community of Orthodox worldwide; and
11	WHEREAS, in 1994, Ecumenical Patriarch Bartholomew, along with leaders of the Appeal
2	of Conscience Foundation, cosponsored the Conference on Peace and Tolerance, which
3	brought together Christian, Jewish, and Muslim religious leaders for an interfaith dialogue to
4	help end the Balkan conflict and the ethnic conflict in the Caucasus region; and
15	WHEREAS, in 1997, the Congress of the United States awarded Ecumenical Patriarch
6	Bartholomew with the Congressional Gold Medal; and
7	WHEREAS, following the terrorist attacks on our nation on September 11, 2001,
8	Ecumenical Patriarch Bartholomew gathered a group of international religious leaders to
9	produce the first joint statement with Muslim leaders that condemned the September 11, 2001,
20	attacks as "antireligious"; and
21	WHEREAS, in October 2005, the Ecumenical Patriarch, along with Christian, Jewish, and
22	Muslim leaders, cosponsored the Conference on Peace and Tolerance II to further promote
23	peace and stability in southeastern Europe and Central Asia via religious leaders' interfaith
24	dialogue, understanding, and action; and

1 WHEREAS, the Orthodox Christian Church, in existence for nearly 2,000 years, numbers 2 approximately 300,000,000 members worldwide with more than 2,000,000 members in the 3 United States; and 4 WHEREAS, since 1453, the continuing presence of the Ecumenical Patriarchate in Turkey 5 has been a living testament to the religious coexistence of Christians and Muslims; and 6 WHEREAS, this religious coexistence is in jeopardy because the Ecumenical Patriarchate 7 is considered a minority religion by the Turkish government; and 8 WHEREAS, the Government of Turkey has limited the candidates available to hold the 9 office of Ecumenical Patriarch to Turkish nationals only, and from the millions of Orthodox 10 Christians living in Turkey at the turn of the 20th century and due to the continued policies during 11 this period by the Turkish government, there remain fewer than 3,000 of the Ecumenical 12 Patriarch's flock left in Turkey today; and 13 WHEREAS, the Government of Turkey closed the Theological School on the island of Halki 14 in 1971 and has refused to allow it to reopen, thus impeding training for Orthodox Christian 15 clergy; and 16 WHEREAS, the Turkish government has confiscated nearly 94 percent of the Ecumenical 17 Patriarchate's properties; and 18 WHEREAS, the European Union, a group of nations with a common goal of promoting 19 peace and the well-being of its peoples, began accession negotiations with Turkey on 20 October 3, 2005; and 21 WHEREAS, the European Union defined membership criteria for accession at the 22 Copenhagen European Council in 1993, obligating candidate countries to achieve certain levels 23 of reform, including stability of institutions guaranteeing democracy, adherence to the rule of 24 law, and respect for and protection of minorities and human rights; and 25 WHEREAS, the Turkish government's current treatment of the Ecumenical Patriarchate is 26 inconsistent with the membership conditions and goals of the European Union; and 27 WHEREAS, Orthodox Christians in this state and throughout the United States stand to 28 lose their spiritual leader because of the continued actions of the Turkish government; 29 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF NORTH DAKOTA, THE 30 HOUSE OF REPRESENTATIVES CONCURRING THEREIN:

- 1 That the North Dakota Legislative Assembly urges the Government of Turkey to uphold and
- 2 safeguard religious and human rights; cease its discrimination of the Ecumenical Patriarchate;
- 3 grant the Ecumenical Patriarch appropriate international recognition, ecclesiastic succession,
- 4 and the right to train clergy of all nationalities; and respect the property rights and human rights
- 5 of the Ecumenical Patriarchate; and
- 6 **BE IT FURTHER RESOLVED**, that the Secretary of State forward copies of this resolution
- 7 to the President of the United States, the United States Ambassador to the Republic of Turkey,
- 8 the Ambassador of the Republic of Turkey to the United States, and the members of the North
- 9 Dakota Congressional Delegation.
