- 1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
- 2 corrections and rehabilitation; to provide for a legislative management study; to provide for a
- 3 report to the budget section; and to provide an exemption registrative intent.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds as may be necessary, are appropriated out of any moneys in the general fund in the state treasury, not otherwise appropriated, and from special funds derived from federal funds and other income, to the department of corrections and rehabilitation for the purpose of defraying the expenses of the department of corrections and rehabilitation, for the biennium beginning July 1, 2011, and ending June 30, 2013, as follows:

The 2011-13 one-time funding amounts are not a part of the entity's base budget for the 2013-15 biennium. The department of corrections and rehabilitation shall report to the appropriations committees of the sixty-third legislative assembly on the use of this one-time funding for the biennium beginning July 1, 2011, and ending June 30, 2013.

SECTION 3. HEART OF AMERICA CORRECTIONAL AND TREATMENT CENTER -

TREATMENT SERVICES PAYMENTS. The department of corrections and rehabilitation shall distribute in twenty-four equal payments the sum of \$1,677,723 from the general fund appropriated in the adult services line item in section 1 of this Act to the heart of America correctional and treatment center for inmate-related treatment services, for the biennium beginning July 1, 2011, and ending June 30, 2013. If the heart of America correctional and treatment center does not accept a sufficient number of inmates to occupy at least ninety-six percent of the average daily treatment program bed count provided for in the contract for the first ten months of each year of the biennium, the department of corrections and rehabilitation shall reduce the monthly payments for the remaining two months of each year. The total reduction for the two months is the sum of the monthly calculation of the number of beds at ninety-six percent occupancy less the number of beds filled multiplied by the daily rate

multiplied by the number of days in the month. The department of corrections and rehabilitation shall refer a sufficient number of inmates to the heart of America correctional and treatment center to allow for the average daily treatment program bed count provided for in the contract to be fulfilled for the biennium beginning July 1, 2011, and ending June 30, 2013.

SECTION 4. EXEMPTION - TRANSFER TO PENITENTIARY LAND FUND. Any amount appropriated to the department of corrections and rehabilitation from the general fund, as provided in chapter 43 of the 2009 Session Laws, not spent or obligated as of June 30, 2011, is not subject to the provisions of section 54-44.1-11 and shall be transferred by the director of the office of management and budget to the penitentiary land fund during the biennium beginning July 1, 2011, and ending June 30, 2013.

SECTION 4. LEGISLATIVE MANAGEMENT STUDY. During the 2011-12 interim, the legislative management shall consider studying the Missouri River correctional center, including the feasibility and desirability of the Missouri River correctional center relocating adjacent to the state penitentiary. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-third legislative assembly.

SECTION 5. REPORT TO BUDGET SECTION. The department of corrections and rehabilitation shall, during the 2011-12 interim, report quarterly to the budget section regarding the progress of the prison expansion project.

SECTION 6. LEGISLATIVE INTENT - NEW FULL-TIME EQUIVALENT POSITIONS. It is the intent of the sixty-second legislative assembly that the department of corrections and rehabilitation not fill any of the forty-nine new full-time equivalent positions for the state penitentiary expansion project prior to ninety days before the estimated completion date of the project.
