- 1 A BILL for an Act to create and enact six new sections to chapter 15-10 of the North Dakota
- 2 Century Code, relating to the provision of matching grants for the advancement of
- 3 postsecondary academics; to provide an appropriation; to provide for a legislative management
- 4 report; and to provide an expiration date.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1.** A new section to chapter 15-10 of the North Dakota Century Code is created 7 and enacted as follows:

11	the institutional foundation is liable to the institution for any shortfall.						
12	SECTION 4. A new section to chapter 15-10 of the North Dakota Century Code is created						
13	and enacted as follows:

1 SECTION 5. A new section to chapter 15-10 of the North Dakota Century Code is created

2 and enacted as follows:

- 3 **Grant review committee Compensation.**
- 4 Each member of the grant review committee is entitled to receive compensation in the

5 amount of one hundred thirty-five dollars per day plus reimbursement for expenses as provided

6 by law for state officers if the member is attending meetings or performing duties directed by the

7 <u>committee. The compensation provided for in this section may not be paid to any member of the</u>

8 <u>committee who receives a salary or other compensation as an employee or official of this state</u>

9 if the individual is serving on the committee by virtue of the individual's state office or state

10 <u>employment.</u>

SECTION 6. A new section to chapter 15-10 of the North Dakota Century Code is created
and enacted as follows:

13 **Definition**.

14 For purposes of this Act, projects dedicated to the advancement of academics include

15 <u>investments in educational infrastructure.</u>

16 **SECTION 7. APPROPRIATION.** There is appropriated out of any moneys in the general 17 fund in the state treasury, not otherwise appropriated, the sum of \$30,000,000, or so much of 18 the sum as may be necessary, to the state board of higher education for the purpose of 19 providing matching grants for projects dedicated exclusively to the advancement of 20 postsecondary academics, for the biennium beginning July 1, 2013, and ending June 30, 2015. 21 SECTION 8. REPORT. Before October 1, 2014, the state board of higher education shall 22 provide a report to the legislative management regarding the number of matching grants that 23 were sought, the number that were awarded, and the manner in which the grants were used. 24 SECTION 9. EXPIRATION DATE. This Act is effective through June 30, 2015, and after that 25 date is ineffective.
