- 1 A BILL for an Act to amend and reenact sections 20.1-03-12, 20.1-03-12.1, and 20.1-03-12.2 of
- 2 the North Dakota Century Code, relating to hunting fees.

## 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 20.1-03-12 of the North Dakota Century Code is

5 amended and reenacted as follows:

## 6 **20.1-03-12. Schedule of fees for licenses and permits.**

- 7 The various license and permit fees are as follows:
- 8 1. For a resident, age sixteen and over, small game hunting license, sixten dollars.
- 9 2. For a nonresident small game hunting license, eighty-fiveninety-four dollars.
- For a resident big game hunting license, twentytwenty-five dollars, except the fee for a
   licensee under age sixteen is teneleven dollars, except as provided in a gubernatorial
   proclamation issued pursuant to section 20.1-08-04.1.
- 4. Except for a nonresident who participates on the same basis as a resident in a lottery
  for deer licenses remaining after the second lottery for residents under subsection 4 of
- 15 section 20.1-03-11, for a nonresident big game hunting license, two hundred twenty
- 16 dollars, and for a nonresident bow license, two hundred <u>twenty</u> dollars, and a
- 17 nonrefundable five dollar application fee must accompany any lottery license fee under
- 18 this subsection, except as provided in a gubernatorial proclamation issued pursuant to
- 19 section 20.1-08-04.1. For a nonresident who participates on the same basis as a
- 20 resident in a lottery for deer licenses remaining after the second lottery for residents,
- 21 fifty dollars.
- 22 5. For a resident fur-bearer license, seven<u>ten</u> dollars.

9		dollars.
10		Class 7. Each craft capable of carrying up to fifteen adults of average weight,
11		twenty-four dollars.
12		Class 8. Each craft capable of carrying sixteen or more adults of average weight,

28	The fees for these licenses and permits must be deposited with the state treasurer and credited		
29	to the game and fish fund. Forty-five dollars of each nonresident big game hunting license fee		
30	must be used for the private land initiative.

SECTION 2. AMENDMENT. Section 20.1-03-12.1 of the North Dakota Century Code is
 amended and reenacted as follows:

## 20.1-03-12.1. Habitat restoration stamp required - Use of revenue - Land purchases not allowed.

5 Except for licenses issued under section 20.1-03-07.3, a habitat restoration stamp is 6 required for every resident and nonresident general game license for which a stamp fee of 7 tenseventeen dollars must be charged. The habitat restoration stamp fee is in addition to the 8 annual general game license fee charged under section 20.1-03-12. Land may not be 9 purchased with habitat restoration stamp moneys. All moneys generated by habitat restoration 10 stamp fees must be placed in the game and fish private land habitat and access improvement 11 fund with fiveeight dollars of the fee allocated to the private land open to sportsmen program. 12 SECTION 3. AMENDMENT. Section 20.1-03-12.2 of the North Dakota Century Code is 13 amended and reenacted as follows: 14 20.1-03-12.2. Hunting license and permit application fees. 15 Each resident applying for a license or permit to hunt elk, moose, or bighorn sheep under 16 this chapter must be assessed a nonrefundable application fee of three five dollars for each

17 license or permit application in addition to the fee charged for the issuance of the license or

18 permit under this chapter. Each nonresident applying for a license or permit to hunt bighorn

19 sheep under this chapter must be assessed a nonrefundable application fee of one hundred

20 dollars in addition to the fee charged for the issuance of a license or permit to hunt bighorn

21 sheep under this chapter.
