## **SENATE BILL NO. 2026**

- 1 A BILL for an Act to create and enact chapters 4.1-52, 4.1-55, and 4.1-56 and section
- 2 4.1-57-18.1 of the North Dakota Century Code, relating to the North Dakota seed department,
- 3 seed potatoes, and seed potato control areas; to repeal chapters 4-10 and 4-26 and sections
- 4 4.1-53-02, 4.1-53-03, 4.1-53-04, 4.1-53-05, 4.1-53-06, 4.1-53-07, 4.1-53-08, 4.1-53-09,
- 5 4.1-53-10, 4.1-53-11, 4.1-53-62, 4.1-57-20, and 4.1-57-21 of the North Dakota Century Code,
- 6 relating to seed potatoes, seed potato control areas, and general provisions regarding the North
- 7 Dakota seed department; to provide a penalty; and to provide a continuing appropriation.

## 8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 9 **SECTION 1.** Chapter 4.1-52 of the North Dakota Century Code is created and enacted as
- 10 follows:
- 11 4.1-52-01. Seed department Location.
- 12 <u>The North Dakota seed department is the official seed-certifying agency of the state. The</u>
- 13 seed department must be located on the campus of North Dakota state university.
- 14 4.1-52-02. Seed department Official seal.
- The seed department shall use an official departmental seal that has been recorded in the
- 16 office of the secretary of state.
- 17 **4.1-52-03. Seed commission membership.**
- The seed commission is the governing board of the seed department. The seed
- 19 <u>commission consists of the following members:</u>
- 20 <u>1. An individual appointed by the North Dakota crop improvement association;</u>
- 21 <u>2. An individual appointed by the North Dakota certified seed potato growers association;</u>
- 22 3. An individual appointed by the North Dakota dry edible bean seed growers
- 23 association;
- 24 <u>4. An individual appointed by the North Dakota agricultural association;</u>

- 1 <u>5.</u> An individual appointed by the North Dakota potato council;
- 2 <u>6. A resident of this state appointed by the northern plains potato growers association;</u>
- 3 7. An individual who operates a seed-conditioning plant approved by the seed
- 4 <u>department, appointed by the North Dakota grain dealers association;</u>
- 5 <u>8. The director of the agricultural experiment station or the director's designee; and</u>
- 6 9. The agriculture commissioner or the agriculture commissioner's designee.
- 7 <u>4.1-52-04. Seed commission Chairman Meetings.</u>
- 8 <u>1. The agriculture commissioner shall serve as the chairman of the seed commission.</u>
- 9 <u>2.</u> The chairman shall call all regular meetings of the seed commission and shall call a
- special meeting within seven days if petitioned to do so by two members of the seed
- 11 <u>commission.</u>
- 12 <u>3.</u> The seed commission shall hold at least two regular meetings each year.
- 13 <u>4.1-52-05. Seed commission Appointment of proxy.</u>
- 14 If a member of the seed commission is unable to attend a meeting of the commission, the
- 15 member may appoint a proxy. The appointment must be in writing and must be presented to the
- 16 <u>chairman. The vote of the proxy is final.</u>
- 17 <u>4.1-52-06. Seed commission Members Compensation.</u>
- Each member of the seed commission, except the agriculture commissioner and the
- 19 <u>director of the agricultural experiment station, is entitled to receive compensation at the rate of</u>
- 20 one hundred thirty-five dollars per day and reimbursement for expenses, as provided by law for
- 21 <u>state officers, if the member is attending a commission meeting or performing duties directed by</u>
- 22 the commission.
- 23 <u>4.1-52-07. Seed commission Powers.</u>
- The seed commission may:
- 25 1. Establish branch offices and laboratories at locations in this state, other than the
- 26 <u>campus of North Dakota state university, if the seed commissioner determines that the</u>
- offices and laboratories are necessary to carry out the duties of the seed commission,
- the seed commissioner, or the seed department;
- 29 2. Dismiss the seed commissioner for cause:
- 30 3. Appoint an acting seed commissioner if the position becomes vacant; and
- 31 4. Engage in efforts to promote and market certified seed produced in this state.

- 1 Prescribe the manner in which the seed and plant samples are to be obtained 2 and delivered to the seed department; 3 <u>6.</u> Provide commodity inspection services upon request; 4 Establish and charge fees for services, subject to the approval of the seed <u>7.</u> 5 commission; 6 8. Provide periodic reports to the seed commission regarding the management and 7 operation of the seed department; 8 Recommend to the seed commission the biennial annual budget and annual salary <u>9.</u> 9 schedules for the seed department; 10 <del>-10. -</del> Submit the seed department's biennial budget, as approved by the seed commission, 11 to the office of management and budget; 12 <del>11.</del>10. Do all things necessary to enforce the chapters over which the commissioner has 13 authority and the rules implementing those chapters; and 14 <del>12.</del>11. Perform any other duties as directed by the seed commission. 15 4.1-52-11. Seed department fund - Continuing appropriation. 16 The seed commissioner shall forward all moneys received under the chapters over <u>1.</u> 17 which the commissioner has authority to the state treasurer for deposit in a special 18 fund known as the seed department fund. All moneys in the seed department fund are 19 appropriated on a continuing basis to the seed department to carry out its statutory 20 and regulatory obligations. 21 <u>2.</u> The seed commissioner shall approve all expenditures made pursuant to the chapters 22 over which the commissioner has authority and shall document the expenditures at the 23 time and in the manner required by the office of management and budget. 24 <u>3.</u> The seed commissioner shall provide a report to the house and senate appropriations 25 committees of the legislative assembly, at the time and in the manner directed by the 26 chairmen of the committees. The report must contain a summary of the department's 27 activities during the current biennium and a statement of revenues and expenditures
  - 4. At the direction of the seed commission, the state treasurer shall invest all available moneys in the seed department fund. The state treasurer shall credit twenty percent of

The sole warranty is that the potatoes were inspected under

- 1 the rules of the seed department or the United States department of agriculture. The seed

Penalties. 7 Any person willfully violating this chapter is guilty of a class A misdemeanor. 1. 8 <u>2.</u> Any person willfully violating this chapter is subject to a civil penalty in an amount not 9 exceeding five thousand dollars for each violation. The civil penalty may be imposed 10 by a court in a civil proceeding or by the seed commissioner. 11 SECTION 3. Chapter 4.1-56 of the North Dakota Century Code is created and enacted as 12 follows: 13 4.1-56-01. Definition. 14 As used in this chapter, unless the context otherwise requires, "potato" means an Irish 15 potato. 16 4.1-56-02. Seed potato control area - Proposal - Notice of meeting. 17 In order to form a seed potato control area, five individuals who own land within the 18 proposed area shall schedule and provide notice of a meeting that is open to all 19 landowners and occupants in the proposed area. 20 The notice must define the boundaries of the proposed seed potato control area. <u>a.</u> 21 <u>b.</u> The notice must be published at least twice, for two successive weeks, in the 22 official newspaper of each county containing land in the proposed seed potato 23 control area. 24 2. If consented to by a majority of the landowners and occupants present at the meeting, 25 a petition to form a seed potato control area may be circulated among all landowners 26 in the proposed area. 27 4.1-56-03. Seed potato control area - Petition for formation. 28 The petition to be circulated, as provided in section 4.1-56-02, must: 29 1. Describe the boundaries of the proposed seed potato control area; and 30 2. State the quality of seed that may be planted within the proposed seed potato control

## 1 4.1-56-04. Seed potato control area - Creation. 2 Once the petition has been signed by at least eighty percent of the persons owning <u>1.</u> 3 land in the proposed seed control area, the petition may be presented to the seed 4 commissioner for approval. 5 <u>2.</u> If the seed commissioner determines that the petition meets the requirements of this 6 chapter, the seed commissioner may order the creation of: 7 The seed potato control area as described in the petition; or a. 8 A seed potato control area having boundaries that are not as extensive as those <u>b.</u> 9 set forth in the petition. 10 <u>3.</u> In the order establishing the seed potato control area, the seed commissioner a. 11 shall prescribe the quality of seed potatoes that may be planted within the control 12 area. The quality prescribed may differ from that set forth in the petition. 13 After the establishment of a seed potato control area, the seed commissioner b. 14 may issue an order changing the quality of seed potatoes that may be planted 15 within the control area. 16 4.1-56-05. Seed potato control area - Governance committee. 17 <u>1.</u> Each seed potato control area must be governed by a committee consisting of three 18 individuals who are appointed by the seed commissioner from a list of landowners or 19 occupants within the control area. 20 <u>2.</u> The terms of office for members of the governance committee and its rules of 21 operation must be provided for in the seed potato control area's bylaws and agreed to 22 by at least eighty percent of the landowners or occupants within the control area. 23 If fewer than three qualified individuals are willing or able to serve as members of the <u>3.</u> 24 governance committee, the governance committee shall consist of the lesser number. 25 If, however, no qualified individual is willing or able to serve on the governance 26 committee, the seed commissioner shall dissolve the seed potato control area. 27

2. Employ and compensate necessary personnel;

- 3. Accept gifts, grants, and donations of money, property, and services to carry out this
   chapter; and
- 4. Do all things necessary and proper to enforce this chapter and any rules adopted to
   4 implement this chapter.
- 5 <u>4.1-56-07. Governance committee Duties.</u>
- 6 The governance committee shall:
- 7 <u>1. Keep a record of its expenses:</u>
- Submit the record to the seed commissioner at the time and in the manner required by
   the seed commissioner; and
- 10 <u>3. Provide reports at the time and in the manner required by the seed commissioner.</u>
- 11 **4.1-56-08.** Prohibition.
- A person may not plant or authorize the planting of seed potatoes other than those
- 13 permitted within the seed potato control area.

- 15 <u>1. The governance committee may impose an assessment at a rate determined by the committee, but not exceeding two and one-half cents per hundredweight</u>
- 17 [45.36 kilograms] on all seed potatoes produced within the control area.
- 2. Any person producing seed potatoes within the control area shall pay the assessment
   at the time and in the manner required by the governance committee.
- 20 <u>4.1-56-10. Shipment of potatoes Payment of assessment.</u>
- A person producing seed potatoes in a seed potato control area may not ship or transport
- 22 the seed potatoes out of the area unless the person pays the assessment provided for in this
- 23 chapter.
- 24 <u>4.1-56-11. Seed commissioner Orders.</u>
- 25 <u>The seed commissioner may by order:</u>
- 26 <u>1. Alter the boundaries of the seed potato control area;</u>
- 27 <u>2. Assign additional powers and duties to the governance committee;</u>
- 28 <u>3. Prescribe requirements for seed selection, seed treatment, field isolation, cultural</u>
  29 practices, disease removal, and insect control:
- 30 4. Prescribe requirements for the governance committee with respect to seed potato
   31 control efforts;

- 1 <u>5.</u> <u>Prescribe or authorize seed quality for use within the control area;</u>
- 2 <u>6.</u> Provide for the inspection, testing, and approval of seed to be used within the control

- 5 <u>seed potato control area.</u>
- 6 <u>4.1-56-12. Seed potato control area Dissolution.</u>
- 7 Upon a showing of good cause, or as otherwise authorized by this chapter, the seed
- 8 commissioner may order the dissolution of a seed potato control area.
- 9 <u>4.1-56-13. Penalty.</u>
- Any person violating this chapter is guilty of a class B misdemeanor.
- 11 **SECTION 4.** Section 4.1-57-18.1 of the North Dakota Century Code is created and enacted
- 12 as follows:
- 13 <u>4.1-57-18.1. Liability Potato crop quantity and quality.</u>
- 14 <u>A warranty of any kind, either expressed or implied, including a warranty of merchantability,</u>
- 15 <u>fitness for a particular purpose, absence of disease, varietal identity, or selection identity, is not</u>
- 16 made by wholesale potato dealers licensed under this chapter, as to the quantity or quality of
- 17 the crop produced from the seed potatoes that were inspected and certified. The sole warranty
- 18 is that the potatoes were inspected under the rules of the seed department or the United States
- 19 <u>department of agriculture.</u>
- 20 **SECTION 5. REPEAL.** Chapters 4-10 and 4-26 and sections 4.1-53-02, 4.1-53-03,
- 21 4.1-53-04, 4.1-53-05, 4.1-53-06, 4.1-53-07, 4.1-53-08, 4.1-53-09, 4.1-53-10, 4.1-53-11,
- 22 4.1-53-62, 4.1-57-20, and 4.1-57-21 of the North Dakota Century Code are repealed.
