- 1 A BILL for an Act to amend and reenact sections 39-04-10.3 and 39-04-10.14 and subdivisions j
- 2 and o of subsection 2 of section 39-04-18 of the North Dakota Century Code, relating to number
- 3 plates for certain veterans.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Section 39-04-10.3 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **39-04-10.3**. Personalized plates.

8 TheAt the request of a registrant, the department may, in its discretion, provide special 9 license plates marked with not more than seven numerals, letters, or ampersands, or 10 combinations of numerals, letters, and ampersands, at the request of the registrant, upon 11 application therefor for a special license plate and payment of an additional fee of twenty-five 12 dollars per registration period, unless the plate is a gold star license plate or a prisoner of war 13 license plate, then there is no additional charge. The department shall make the special license 14 plates authorized by this section available for motor vehicles registered under section 15 39-04-10.6, trailers, travel trailers, and motorcycles. The fee for the special license plates issued 16 under this section for vehicles registered under section 39-04-10.6 is a one-time fee of one 17 hundred dollars. The special license plates for motorcycles may contain not more than six 18 numerals, letters, or ampersands, or a combination of not more than six numerals, letters, and 19 ampersands. In the event of sale or transfer of the vehicle, the owner must remove the special 20 license plates in accordance with section 39-04-36. Upon payment of the applicable transfer 21 fee, the special license plates may be transferred to a replacement motor vehicle. 22 SECTION 2. AMENDMENT. Section 39-04-10.14 of the North Dakota Century Code is 23 amended and reenacted as follows:

Subdivisions j and o of subsection 2 of section 39-04-18 of the 12 North Dakota Century Code are amended and reenacted as follows: 13 Motor vehicles not exceeding twenty-six thousand pounds [11793.40 kilograms] j. 14 registered gross weight owned and operated by a disabled veteran under the 15 provisions of Public Law 79-663 [38 U.S.C. 3901], a disabled veteran who has a
- 16 one hundred percent service-connected disability as determined by the 17 department of veterans' affairs, or a disabled veteran who has an extra-schedular 18 rating to include individual unemployability that brings the veteran's total disability 19 rating to one hundred percent as determined by the department of veterans' 20 affairs is entitled to display a distinctive license plate issued by the department 21 upon the payment of a fee of five dollarsor a North Dakota veteran's license plate 22 at no charge. A surviving spouse of a disabled veteran who has not remarried 23 and is receiving department of veterans' affairs dependency and indemnity 24 compensation retains the exemption of the deceased disabled veteran who 25 gualified under this subdivision for one vehicle. This exemption applies to no 26 more than two such motor vehicles owned by a disabled veteran at any one time. 27 Passenger motor vehicles, house cars, or pickup trucks not exceeding twenty ο. 28 thousand pounds [9071.84 kilograms] registered gross weight owned and 29 operated by a resident who, while serving in the United States armed forces, was 30 a prisoner of war and has received an honorable discharge from the United 31 States armed forces; provided, however, that the vehicles is entitled to display a

13	of the deceased veteran who qualified under this subdivision for one vehicle.
