- 1 A BILL for an Act to amend and reenact section 36-09-20 of the North Dakota Century Code or
- 2 in the alternative to amend section 4.1-73-18 of the North Dakota Century Code, relating to bill
- 3 of sale requirements in livestock transactions.

4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. AMENDMENT. If House Bill No. 1026 does not become effective, section							
6	36-09-20 of the North Dakota Century Code is amended and reenacted as follows:							
7	36-09-20. Bill of sale to be given and kept - Copy with shipment - Effect - Penalty.							
8	1.	Ap	erson may not sell cattle, horses, mules, or any other livestock carrying a					
9	registered brand unless:							
10		a.	The the seller is the owner of the registered brand and delivers a bill of sale for					
11			the cattle, horses, mules, or other livestock to the purchaser ; or					

- 12 b. The seller delivers to the purchaser a bill of sale executed by the owner of the
 13 registered brand and endorsed by the seller evidencing the later transaction.
- 14 2. The bill of sale must include:
- 15 a. The date;
- 16 b. The name, address, and signature of the seller;
- 17 c. The name, address, and signature of an individual who is at least eighteen years
 18 of age and who can verify the name and signature of the seller;
- 19 d. The name and address of the buyer;
- 20 e. The total number of animals sold;
- 21 f. A description of each animal sold as to sex and kind; and
- 22 g. A description of the registered brands.
- 3. The bill of sale must be kept by the buyer for two years and as long thereafter as the
 buyer owns any of the animals described in the bill of sale.
