1 A BILL for an Act to create and enact a new section to chapter 57-15 of the North Dakota

- 2 <u>Century Code, relating to the authorization of a school district mill levy for an early childhood</u>
- 3 education program; and to amend and reenact section 15.1-09-58 of the North Dakota Century
- 4 Code, relating to early childhood education; and to provide an appropriation for early childhood
- 5 education grants.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7 SECTION 1. AMENDMENT. Section 15.1-09-58 of the North Dakota Century Code is

8 amended and reenacted as follows:

9 15.1-09-58. Prekindergarten programEarly childhood education - Authorization -

- 10 Support.
- 11 The board of a school district may establish a prekindergartenan early childhood education
- 12 program and, provided the program is approved by the superintendent of public instruction in
- 13 accordance with chapter 15.1-37, may receive and expend any state support that program with:
- Local tax revenues, other than those necessary to support the district's kindergarten
 program and the provision of elementary and high school educational services;
- 16 <u>2.</u> <u>State</u> moneys specifically appropriated for the program, any federal;
- 17 <u>3.</u> <u>Federal</u> funds specifically appropriated or approved for the program, and any gifts: and
- 18 <u>4.</u> <u>Gifts</u>, grants, and donations specifically given for the program.

19 **SECTION 2. APPROPRIATION.** There is appropriated out of any moneys in the general-

20 | fund in the state treasury, not otherwise appropriated, the sum of \$4,683,000, or so much of the

- 21 sum as may be necessary, to the superintendent of public instruction for the purpose of
- 22 providing annual early childhood education grants to eligible school districts, for the biennium-
- 23 beginning July 1, 2013, and ending June 30, 2015.
