"SECTION 1. AMENDMENT. Section 5-01-08.1 of the North Dakota Century Code is amended and reenacted as follows:

5-01-08.1. Misrepresentation of age - Penalty - Licensee may keep book.

An individual who misrepresents or misstates that <u>person'sindividual's</u> age or the age of <u>any other personanother individual</u> or who misrepresents that <u>person'sindividual's</u> age through presentation of any document purporting to show that <u>personindividual</u> to be of legal age to purchase alcoholic beverages is guilty of a class B misdemeanor for a first offense. For a first offense, the court shall sentence the individual to a minimum fine of five hundred dollars and forty hours community service. For a second offense, the individual is guilty of a class A misdemeanor. For a second offense, the court shall sentence the individual to a minimum fine of one thousand dollars and eighty hours community service. For a third offense, the individual is guilty of a class C felony. Any licensee may keep a book and may require anyone who has shown documentary proof of that <u>person'sindividual's</u> age, which substantiates that <u>person'sindividual's</u> age to allow the purchase of alcoholic beverages, to sign the book if the age of that <u>personindividual</u> is in question. The book must show the date of the purchase, the identification used in making the purchase and the appropriate numbers of such identification, the address of the purchaser, and the purchaser's signature."
