- 1 A BILL for an Act to amend and reenact section 54-21.3-03 of the North Dakota Century Code,
- 2 relating to the membership of the state building code advisory committee.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. AMENDMENT. Section 54-21.3-03 of the North Dakota Century Code is

5 amended and reenacted as follows:

6 **54-21.3-03. State building code.**

- The department of commerce, in cooperation with the state building code advisory
 committee, shall adopt rules to implement, amend, and periodically update the state
 building code, which must consist of the international building, residential, mechanical,
 and fuel gas codes.
- 11 2. The state building code advisory committee consists of:
- a. Two representatives appointed by the North Dakota building officials association,
 one of whom must be from a jurisdiction of fewer than ten thousand people.
- b. One representative appointed by the North Dakota chapter of the Americaninstitute of architects.
- 16 c. One representative appointed by the North Dakota society of professional
 17 engineers.
- 18 d. One representative appointed by the North Dakota association of builders.
- e. One representative appointed by the North Dakota association of <u>plumbing</u>,
 <u>heating</u>, and mechanical contractors.
- f. One representative appointed by the associated general contractors.
- 22 g. A fire marshalofficial appointed by the state fire marshal.
- h. One individual appointed by the state electrical board.

1	3.	The state building code advisory committee shall meet with the department of
2		commerce or a designee of the commissioner of commerce at least once each
3		calendar year to address proposed amendments to the state building code. The
4		department of commerce may not adopt an amendment to the state building code
5		unless the amendment is approved by a majority vote of :
6		a. One representative appointed by the North Dakota chapter of the American-
7		institute of architects;
8		b. One representative appointed by the North Dakota society of professional
9		engineers;
10		c. One representative appointed by the North Dakota association of builders;
11		d. One representative appointed by the North Dakota association of mechanical
12		contractors; and
13		e. One representative appointed by the associated general contractors; and
14		f. Representatives of eligible jurisdictions as established by administrative rule the
15		state building code advisory committee.
16	4.	The state building code or a building code adopted by a city, township, or county may
17		not include a requirement that fire sprinklers be installed in a single family dwelling or
18		a residential building that contains no more than two dwelling units. The state building
19		code, plumbing code, electrical code, or an equivalent code adopted by a political
20		subdivision must provide that a building designed for and used as a school portable
21		classroom may be constructed and inspected as a temporary structure as defined by
22		the state building code or may be permitted as a permanent school portable
23		classroom. The foundation system of such a structure must comply with the
24		recommendations of the manufacturer's engineering report for a preengineered unit or
25		a structural engineer's report. Frost-free footings may not be required for a temporary
26		structure that meets the requirements of the state building code unless required by an
27		engineering report. Temporary electrical and plumbing installations may be allowed for
28		any structure by the governmental entities governing those areas of construction or
29		the applicable codes.
30	5.	For the purposes of manufactured homes, the state building code consists of the
31		manufactured homes construction and safety standards under 24 CFR 3280 adopted

	pursuant to the Manufactured Housing Construction and Safety Standards Act
	[42 U.S.C. 5401 et seq.].
6.	The governing body of a city, township, or county that elects to administer and enforce
	a building code shall adopt and enforce the state building code. However, the state
	building code may be amended by cities, townships, and counties to conform to local
	needs.
7.	A modular residential structure or a prebuilt home placed in the state must be
	constructed in compliance with the state building code. A modular residential structure
	or a prebuilt home placed in a jurisdiction that has amended the state building code
	must be constructed in compliance with the state building code and the amendments
	adopted by that jurisdiction.
