4	BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:	
5	SECTION 1. Chapter 61-41 of the North Dakota Century Code is created and enacted as	
6	follows:	
7	61-41-01. Definitions.	
8	For purposes of this chapter:	
9	<u>1.</u>	"Fresh water" means fresh water drawn from an underground or surface source in this
10		state under an industrial use water permit, whether treated or untreated, and
11		dispensed to an oil and gas industry user.
12	<u>2.</u>	"Oil and gas industry user" means an enterprise engaged in exploration, drilling, or
13		production of oil and gas, and includes businesses that transport water for use in such
14		an enterprise.
15	61-41-02. Oil and gas industry fresh water user fee.	
16	A fee of twenty cents per one hundred gallons [378.54 liters] is imposed on fresh water

The operator of a water depot or water-dispensing point in this state which dispenses fresh water to an oil and gas industry user shall collect and remit the fee imposed by this chapter to

- 3 treasurer, who shall deposit the fees in the oil and gas impact grant fund.

- 5 The provisions of chapter 57-39.2, pertaining to the administration of the sales tax, including
- 6 reporting, filing of returns, penalties, liens, rule making authority, and any other provisions not in
- 7 conflict with the provisions of this chapter, govern the administration, with the exception that the
- 8 <u>state water commission shall exercise those powers under this chapter.</u>
- 9 **SECTION 2. EFFECTIVE DATE.** This Act becomes effective July 1, 2013.
