The bill allows a nonresident (NR) an additional seven-day waterfowl license.

This bill amendment will have a positive fiscal impact on our revenue because it is adding an additional NR seven-day waterfowl license to be purchased.

It is difficult to estimate how many NR hunters will buy an additional license; one reason is the season is dependent on weather. Although, it's not equivalent, we decided to base our estimate on how many NR hunters purchased multiple small game licenses. This came to 3%. Based on 2012 NR waterfowl license sales, we estimate that 500 additional seven-day waterfowl licenses will be sold which equals \$62,500 (500 x \$125) per year. Total revenue for a biennium is \$125,000. The proposed bill will take effect for the 2014 season. Therefore, only 1 year in the 2013-15 biennium will be affected.
