4 died May 16, 2012;

5 Arthur Henry Behm, who served in the 60th and 61st Legislative Assemblies, from District 19,
6 died July 6, 2012;

7 Dennis Bercier, who served in the 56th through the 59th Legislative Assemblies, from
8 District 9, died June 11, 2012;

9 Thomas L. Fischer, who served in the 55th through the 62nd Legislative Assemblies, from
10 District 46, died November 16, 2011;

11 Herbert T. Geving, who served in the 40th Legislative Assembly, from District 4, died April 23,
12 2011;

13 Erwin "Bud" Hanson, who served in the 51st and 52nd Legislative Assemblies, from District 2,
14 died October 7, 2011;

15 Orlin Milton "Bill" Hanson, who served in the 52nd Legislative Assembly, from District 3, died
16 October 13, 2012;

17 Ludger Kadlec, who served in the 39th Legislative Assembly, from District 3, died
18 September 16, 2012;

19 George Longmire, who served in the 35th through the 39th Legislative Assemblies, from
20 District 7, and in the 40th through the 44th Legislative Assemblies, from District 18, died
21 March 25, 2012;

22 Ernest G. Pyle, who served in the 40th through the 44th Legislative Assemblies, from
23 District 22, died May 28, 2011;

24 Earl H. Redlin, who served in the 39th Legislative Assembly, from District 25, and in the 40th
25 through 42nd Legislative Assemblies, from District 28, died December 21, 2012;

1 Rolland "Rollie" Redlin, who served in the 36th through the 38th Legislative Assemblies, from
2 District 40, in the 43rd and 44th Legislative Assemblies, from District 5, in the 45th through the
