1 A BILL for an Act to amend and reenact subsections 1 and 2 of section 43-39-01, sections

- 2 43-39-05, and 43-39-08, subsection 3 of section 43-39-09, subsection 2 of section 43-39-10,
- 3 and section 43-39-11 of the North Dakota Century Code, relating to athletic trainers; to repeal
- 4 section 43-39-07 of the North Dakota Century Code, relating to grandfathering initial licensees;
- 5 and to provide a penalty.

6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

7	SECTION 1. AMENDMENT. Subsections 1 and 2 of section 43-39-01 of the North Dakota
8	Century Code are amended and reenacted as follows:
9	
10	43-39-05, who is providing athletic traininghealth care professional who collaborates
11	with physicians to optimize patient and client activity and participation in athletics,
12	work, and life.
13	<u>2. "Athletic training" means the practice of prevention, examination and diagnosis,</u>
14	recognition, evaluation, management, treatment, and disposition of athletic injuries.
15	The term also means rehabilitation of athletic injuries, if under the order of a licensed
16	physician. The term includes organization and administration of educational programs,
17	athletic facilities, and the education and counseling of the publicrehabilitation of
18	emergent, acute, subacute, and chronic neuromusculoskeletal conditions and certain
19	medical conditions in order to minimize subsequent impairments, functional limitations,
20	disability, and societal limitations. Athletic trainers work in varying settings, including
21	recreational facilities, schools, colleges, universities, professional sports teams,
22	hospitals, rehabilitation clinics, physicians' offices, corporate and industrial institutions,
23	the military, and the performing arts. Regardless of their practice setting, athletic

3	SECTION 1. AMENDMENT. Section 43-39-05 of the North Dakota Century Code is		
4	amended and reenacted as follows:		
5	43-39-05. Qualifications.		
6	To b	e eligible for an athletic trainer license, an applicant must meet all the requirements of	
7	certification established by the national athletic trainers association board of certification,		
8	incorporated.		
9	SECTION 2. AMENDMENT. Section 43-39-08 of the North Dakota Century Code is		
10	amended and reenacted as follows:		
11	43-39-08. Examination required.		
12	All li	cense applicants must pass anhave previously passed the board of certification,	
13	incorporated, examination prescribed by the board unless they show proof of passage of a		
14	board-approved equivalent examination. The athletic trainer's examination must embrace such		
15	criteria as may be determined by the board.		
16	SECTION 3. AMENDMENT. Subsection 3 of section 43-39-09 of the North Dakota Century		
17	Code is amended and reenacted as follows:		
18	3.	A previously licensed person who leaves the person's position of employment as an	
19		athletic trainer for any reason for one year or more and has requested license renewal	
20		must show continued education credits as established and approved by the	
21		boardhave active status from the board of certification, incorporated.	
22	SECTION 4. AMENDMENT. Subsection 2 of section 43-39-10 of the North Dakota Century		
23	Code is amended and reenacted as follows:		
24	2.	Nothing in this chapter shall be construed to authorize the practice of medicine by any	
25		person. The provisions of this chapter do not apply to physicians licensed by the North	
26		Dakota state board of medical examiners; to dentists, duly qualified and registered	
27		under the laws of this state who confine their practice strictly to dentistry; to licensed	
28		optometrists who confine their practice strictly to optometry as defined by law; to	
29		licensed chiropractors who confine their practice strictly to chiropractic as defined by	
30		law; to occupational therapists who confine their practice to occupational therapy; to	
31		nurses who practice nursing only; to duly licensed chiropodists or podiatrists who

- 1 confine their practice strictly to chiropody or podiatry as defined by law; to registered
- 2 physical therapists; to masseurs or masseuses massage therapists in their particular
- 3 sphere of labor; nor to commissioned or contract physicians or physical therapists or
- 4 physical therapists' assistants in the United States army, navy, air force, marine corps,
- 5 and public health and marine health service.
- 6 SECTION 5. AMENDMENT. Section 43-39-11 of the North Dakota Century Code is
- 7 amended and reenacted as follows:
- 8 **43-39-11.** Penalty.
- 9 Any person violating any of the provisions of practicing as an athletic trainer without a
- 10 <u>license as required by</u> this chapter is guilty of a class B misdemeanor.
- 11 **SECTION 6. REPEAL**. Section 43-39-07 of the North Dakota Century Code is repealed.
