BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- SECTION 1. AMENDMENT. Subsection 3 of section 49-03-02 of the North Dakota Century
 Code is amended and reenacted as follows:
 - The commission may impose an application fee of up to one hundred twenty-fiveseventy-five thousand dollars for an application under this chapter. With the approval of the emergency commission, the commission may impose an additional amount. The commission shall pay the expenses of processing an application under this chapter from the application fee paid by the public utility in accordance with section 49-02-02.
 - **SECTION 2. AMENDMENT.** Subsection 11 of section 49-05-04 of the North Dakota Century Code is amended and reenacted as follows:
 - 11. An application fee in the amount of one hundred twenty-fiveseventy-five thousand dollars. Upon request of the commission and with the approval of the emergency commission, the applicant shall pay such additional fees as are reasonably necessary for completion of the application process by the commission. The commission shall pay the expenses of investigating a rate increase application under this section from the application fee paid by the public utility in accordance with section 49-02-02. The commission may waive or reduce the fee.
 - **SECTION 3. AMENDMENT.** Subsection 2 of section 49-05-04.2 of the North Dakota Century Code is amended and reenacted as follows:

29			anticipated commercial operation of the resource addition;
30		b.	The public utility files with its application a fee in the amount of one hundred
31			twenty-fiveseventy-five thousand dollars. Upon request of the commission and

- with the approval of the emergency commission, the applicant shall pay such additional fees as are reasonably necessary for completion of the application process by the commission. The commission may waive or reduce the fee.

 The commission provides notice and holds a hearing, if appropriate, in accordance with section 49-02-02; and
 - d. The commission determines that the resource addition is prudent. For facilities located or to be located in this state the commission, in determining whether the resource addition is prudent, shall consider the benefits of having the resource addition located in this state.
