- 1 A BILL for an Act to amend and reenact subsection 2 of section 39-01-01 and subsection 2 of
- 2 section 39-10-03 of the North Dakota Century Code, relating to definitions of and lights used by
- 3 authorized emergency vehicles.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 SECTION 1. AMENDMENT. Subsection 2 of section 39-01-01 of the North Dakota Century

6 Code is amended and reenacted as follows:

- 7 2. "Authorized emergency vehicles":
- 8 a. "Class A" authorized emergency vehicles means:
  - (1) Vehicles of a governmentally owned fire department.
- 10 (2) Vehicles when operated by or under the control of a police officer having 11 authority to enforce the provisions of this title or by a salaried employee of a 12 municipal police department within the municipality or by a sheriff or deputy 13 sheriff not including special deputy sheriffs, or by the director of the 14 department of corrections and rehabilitation and the director's authorized 15 agents who have successfully completed training in the operation of class A 16 authorized emergency vehicles.
- 17 (3) Vehicles clearly identifiable as property of the department of corrections and
  18 rehabilitation when operated or under the control of the director of the
  19 department of corrections and rehabilitation.
  - (4) Ambulances.
- (5) Vehicles operated by or under the control of the director, district deputy
   director, or a district deputy game warden of the game and fish department.
- 23 (6) Vehicles owned or leased by the United States and used for law24 enforcement purposes.

19	SECTION 2. AMENDMENT. Subsection 2 of section 39-10-03 of the North Dakota Century					
20	Code is amended and reenacted as follows:

22		a.	Wh	en the authorized emergency vehicle is in pursuit of or apprehension of a		
23			viola	ator or a suspected violator requiring the use of these exemptions.		
24		b.	Wh	en the class A authorized emergency vehicle is being operated in response to		
25			a re	ported emergency involving a possible personal injury, death, or damage to		
26			pro	perty, and when giving adequate warning by use of a flashing red or		
27			con	nbination red and white lights that are visible under normal atmospheric		
28			con	ditions for at least five hundred feet [152.4 meters] and if appropriate, giving		
29			aud	lible signal by siren or airhorn. A fire truck, ambulance, or law enforcement		
30			veh	icle that is otherwise a class A authorized emergency vehicle may display a

1		flashing blue light in addition to and under the same conditions as the other
2		colors allowed in this subdivision.
3	C.	In any instance when the head of a law enforcement agency deems advisable
4		within the area of that person's jurisdiction for the protection of person and
5		property and when giving audible signal by siren or when giving adequate
6		warning by use of a flashing red or combination red and white lights which are
7		visible under normal atmospheric conditions for at least five hundred feet [152.4
8		meters]. A fire truck, ambulance, or law enforcement vehicle that is otherwise a
9		class A authorized emergency vehicle may display a flashing blue light in addition
10		to and under the same conditions as the other colors allowed in this subdivision.
