1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;

2 to amend and reenact subsection 18 of section 54-11-01, section 54-11-13, and subsection 5 of

3 section 57-51.2-02 of the North Dakota Century Code, relating to the duties and salary of the

4 state treasurer and a tribal oil and gas agreement; to provide legislative intent; and to declare

5 an emergency.

## 6 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the funds
as may be necessary, are appropriated out of any moneys in the general fund in the state
treasury not otherwise appropriated, to the state treasurer for the purpose of defraying the
expenses of that agency, for the biennium beginning July 1, 2013, and ending June 30, 2015,
as follows:

20 SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO

21 SIXTY-FOURTH LEGISLATIVE ASSEMBLY. The following amounts reflect the one-time

22 funding items approved by the sixty-second legislative assembly for the 2011-13 biennium and

the 2013-15 one-time funding items included in the appropriation in section 1 of this Act:

7 2015-17 biennium. The state treasurer shall report to the appropriations committees of the

8 sixty-fourth legislative assembly on the use of this one-time funding for the biennium beginning

9 July 1, 2013, and ending June 30, 2015.

SECTION 3. AMENDMENT. Subsection 18 of section 54-11-01 of the North Dakota Century
 Code is amended and reenacted as follows:

- 12 18. Shall correct any underpayment, overpayment, or erroneous payment of tax
- 13 distribution funds, resulting from an error made by the state treasurer in a timely

14 manner. Unless otherwise provided by law, adjustments may be made from the

- 15 general fund. This authority is limited to one hundred dollars per biennium, unless
- 16 approved by the emergency commission. An adjustment of an insignificant amount
- need not be made at the discretion of the state treasurer. The state treasurer shall
  adopt a written policy identifying what is considered insignificant.
- 19 SECTION 4. AMENDMENT. Section 54-11-13 of the North Dakota Century Code is
- 20 amended and reenacted as follows:
- 21 **54-11-13**. Salary of state treasurer.
- 22 The annual salary of the state treasurer is <u>eighty-five\_ninety-one</u> thousand <u>threefour</u> hundred
- 23 thirtysix dollars through June 30, 20122014, and eighty-sevenninety-four thousand eight-
- 24 hundred ninetyone hundred forty-eighty dollars thereafter.
- 25 SECTION 5. AMENDMENT. Subsection 5 of section 57-51.2-02 of the North Dakota
- 26 Century Code is amended and reenacted as follows:
- 5. The allocation of revenue from oil and gas <u>gross</u> production <u>and oil extraction</u> taxes on
  the Fort Berthold Reservation must be as follows:
- a. Production attributable to trust lands. All revenues and exemptions from all oil
  and gas gross production and oil extraction taxes attributable to production from

1		trust lands on the Fort Berthold Reservation must be evenly divided between the	
2		tribe and the state.	
3	b.	All other production. The tribe must receive twenty percent of the total oil and gas	
4		gross production taxes collected from all production attributable to nontrust lands	
5		on the Fort Berthold Reservation in lieu of the application of the Three Affiliated	
6		Tribes' fees and taxes related to production on such lands. The state must	
7		receive the remainder.	
8	С.	The state's share of the oil and gas gross production tax revenue as divided in	
9		subdivisions a and b is subject to distribution among political subdivisions as	
10		provided in chapterschapter 57-51 and 57-51.1.	
11	SECTION 6. LEGISLATIVE INTENT - STATE TREASURER'S SALARY. It is the intent of		
12	the sixty-third legislative assembly that the salary of the state treasurer be increased to the		
13	salary of the next lowest-paid elected official effective July 1, 2017.		
14	SECTION 7. EMERGENCY. The sum of \$195,223 and one full-time equivalent position		
15	included in section 1 of this Act are declared to be an emergency measure.
