The amendments to HB 1009 amend Sections 19-13.1 and 4-01-21 relating to license, inspection, and registration fees, and the agriculture commissioner's salary.

The amendments made the following changes: 1. Section 19-13.1: the first \$485,000 of fees will be deposited in the environment and rangeland protection fund. The funds were previously deposited in the general fund. 2. Section 4-01-21: the agriculture commissioner's salary was reduced. 3. Funding for the Centennial Farm Program was removed (\$80,000). 4. The House of Representatives' reduced the compensation and benefit package.

The House Appropriations Committee determined the amount necessary to support decreasing Game & Fish Department funding in this budget.
